Chairman Kick, Ranking Member O'Brien and members of the House Finance Sub-Committee on Agriculture, Development and Natural Resources,

My name is Anita Spencer, and I am the President and Owner, of Safe Choice LLC. We are a security company providing armed and unarmed security officers and police officers for public and private organization. I appreciate the opportunity to testify in support of the women-owned business loan fund as contained in House Bill 110, which would provide \$10 million over the biennium for small loans to women-owned businesses in Ohio.

Women businesses have been hit harder by the pandemic because women are the primary caregivers in the household. With the schools being closed, women can't find safe child care. Also, in home school is great when a woman is able to work from home, however, if not afforded that opportunity, it is difficult to care for and educate your children. Women businesses have not been identified as needing funding in previous state budgets, and they have not invested in women especially on the front end.

Thank you for the opportunity to provide testimony in support of this important program. I urge your support and favorable vote for the full \$10 million women-owned business loan fund as proposed in the executive budget.
