Chairman Peterson, Vice Chair Schuring, Ranking Minority Member Williams and members of the committee. My name is Debbie Krajicek. I am a Cedarville Township Trustee from Greene County. I am writing on behalf of our Board in support of SB52, and would like to address some of the issues that we are facing in our Township.

We currently have a project that is proposed for our area called Kingswood Solar 1. As of date 17 property owners have signed leases on 1800 acres of prime farm ground spanning three Townships, (Cedarville, Miami, and Xenia). The proposed site for the project is located in one of our most scenic areas along John Bryan State Park, Glen Helen Nature Preserve, Little Miami Scenic River Corridor etc. The only consideration that is looked at by the Leasing Company is where the power lines run, and how they can connect to the grid. The power generated from this slated to go to the East Coast, and doesn't benefit our area.

Under current law the Townships are at a disadvantage for the following reasons:

The project is not in accordance with Local Zoning and our County land use plan.

Time line for intervening is very restrictive and specific. By the time you know about the project you don't have enough time to respond.

In order for Townships to intervene at the OPSB we have to hire outside Attorneys which puts a huge financial burden on our budgets.

The cumulative effect of multiple projects could overburden community.

It is for these reasons that we ask you to please pass SB 52 and allow Local Government to have a say in what impacts their citizens and community.
