PROFESSIONAL SUMMARY

Mr. Graham brings 42 years of experience to the company. He was employed at Ohio DOT (ODOT) for more than 32 years in a variety of positions, including staff archaeologist, transportation planner, District 5 environmental coordinator, and assistant environmental administrator in the Office of Environmental Services. In this last position, he served as head of ODOT's cultural resource management program from 1997 to 2011, overseeing ODOT compliance with Section 106 of the National Historic Preservation Act and Section 4(f) for historic sites under the Department of Transportation Act. He also had general NEPA responsibilities in that position. During his last two years, he oversaw all Section 4(f) compliance.

Mr. Graham was the primary author of the first Section 106 delegation PA between ODOT, FHWA, the Ohio State Historic Preservation Office, and the Advisory Council on Historic Preservation; authored two Memoranda of Understanding and one state-funded project agreement; and worked on many project Memoranda of Agreement. He conducted tribal consultation on behalf of FHWA, supervised the ODOT archaeology and history/architecture staff, and led the agency's historic bridge management program, working with structural engineers in ODOT, Ohio counties and cities. He has considerable experience compiling and contributing to all levels of NEPA documents: CE, EA/FONSI, and EIS. Through his long career he has gained extensive experience with public involvement under NEPA, Section 106, and Section 4(f).

In the ODOT's training classes, he was primary instructor in the *Section 106 Training*. He was also an instructor in the following training classes: *Section 4(f)/Section 6(f) Training, Purpose and Need Training, Categorical Exclusion Training*, and *NEPA: Managing the Environmental and Project Development Process*.

Mr. Graham also is the primary author of several manuals related to cultural resource management/Section 106 compliance, project development, Section 4(f), and NEPA for ODOT. His experience includes working with communities on Context Sensitive Solutions, Smart Streets, and he assisted in developing the ODOT Aesthetic Design Guidelines. He has multi-modal transportation experience. He worked with the ODOT Division of Rail Transportation on freight rail projects, for five years helped plan and develop statewide multi-use trails, and has experience with port, harbor, and intermodal projects. In addition, he has experience developing and designing content for ODOT webpages.
