Chairman Roegner, Vice Chairman McColley, Ranking Member Craig, and members of the State and Local Government Committee:

I am testifying today in favor of SB22 as an Ohio resident deeply concerned about courses of action being taken under the current emergency powers and the dire effects it is having on all of us. Additionally, my family has been severely impacted by the continued policies and mandates that our governor has put in place.

As a parent of a special needs child, it has been extremely difficult if not impossible for our son to receive Occupational Therapy and Speech Therapy when his school is shut down (he is on an IEP). This affects our ability to get the services our son needs so he can be successful in life (and a productive member of society). Our Governor's mandates CONTINUES to hamper the special needs community across all of Ohio.

Additionally, our family has been further affected by the mandates as we have had a recent close member of our family pass away in December of 2020. An Uncle died in a nursing facility with NO FAMILY ALLOWED to be present and ONLY 25 people to be allowed at his funeral. I wasn't able to attend the funeral either. Nobody from our family was allowed to be with him when he passed away. This is WRONG and needs to be corrected.
