# Fair Maps and redistricting

## **Senate Local Government Elections Committee**

My name is Dr. Mark Ryland, I live in Stow, Ohio and work at Cuyahoga Community College as an Associate Professor in an Allied Health Career Field.

I am appalled yet not one bit surprised that Ohio House and Senate Republicans have come up with their own proposed congressional map that gives them 87% (13 of 15 congressional seats). You were told by the majority of voters in 2018 that FAIRER maps were needed and you dragged your feet for three years and did nothing. The inaction was driven by partisan politics and was obviously purposeful. Now you want to ram-rod an even less fair map down our throats in the 11<sup>th</sup> hour.

You have also apparently not even followed the proper protocol of forming a joint legislative committee which the Constitution calls for. Rather, the House and Senate have only held committee hearings on proposed maps.
