Chair Brenner, Ranking Member Fedor, and members of the Senate Primary and Secondary Education Committee, thank you for the opportunity to provide interested party testimony regarding H.B.110.

My name is Erica Duquette Miley and on behalf of St. Benedict Catholic School in Toledo, Ohio, sponsored by Little Flower and Our Lady of Lourdes Catholic Parishes, I implore you to continue to offer and fully fund the scholarship programs in the state of Ohio. The Traditional EdChoice and Edchoice Expansion scholarships have enriched not only the lives of the children and families receiving them, but our entire school community.

As a mother of two St. Benedict students first, I also serve as marketing director for the school. I have seen firsthand the value these vouchers bring for families who would otherwise be in a failing school system and to those who do not have the same socio-economic advantages as other families.
