

TESTIMONY OF RICHARD OHANIAN REGARDING PROPOSED OHIO SPORTS-BETTING LEGISLATION

COMMENTS AND AN ALTERNATIVE "CLASS "C"" PROPOSAL THIS 12TH DAY OF MAY 2021

INTRODUCTION:

THANK-YOU, CHAIRMAN SCHURING, FOR ALLOWING ME TO TESTIFY TODAY REGARDING THE PROPOSED LEGISLATION FOR SPORTS-WAGERING IN OHIO.

I WAS IN THE FETAL POSITION AFTER LAST THURSDAY'S PRESS CONFERENCE, BECAUSE I COULDN'T BELIEVE SOME OF THE THINGS I HEARD, BUT AFTER I SCRAPED MYSELF OFF THE FLOOR AND SLEPT IT OFF ALL AFTERNOON, I REALIZED THERE WAS A LIGHT AT THE END OF THE TUNNEL AND A VERY BIG ONE AT THAT - FOR BOTH OF US.

AND THAT LIGHT IS THE FACT THAT MY "COMPROMISE PLAN" CAN STILL BE DONE IN CONJUNCTION WITH EVERYTHING YOU HAVE PRESENTED.

YOU ARE TO BE COMMENDED AND APPLAUDED, SIR, FOR THIS "CLASS B" PLAN, AS IT WILL BRING BILLIONS IN ECONOMIC DEVELOPMENT TO THE STATE. BUT YOU DON'T HAVE TO THROW THE BABY OUT WITH THE BATHWATER, AS MY LOTTERY TICKET DISPENSER OPERATION WITH THE OHIO LOTTERY CAN STILL BE DONE AND BRING-IN THE STATE AN EXTRA \$350-\$400 MILLION FOR THE SCHOOL SYSTEM.

IT WILL ALSO BRING "THE LITTLE GUY" BACK INTO THE GAME. ALL THE LITTLE BARS, RESTAURANTS, BOWLING ALLEYS, GROCERY STORES, CONVENIENCE MARTS AND ANYONE ELSE CAN NOW PARTICIPATE IN MY PLAN AT A RATE OF FIVE-PERCENT, (05%), OF GROSS, IF YOU CREATE WHAT I CALL A CLASS "C" LICENSE AND LET ME RUN IT THROUGH THE LOTTERY.

A CLASS "C" LICENSE:

A CLASS "C" LICENSE WOULD BE A ONE-TIME FEE OF \$1,000 WITH A RENEWAL FEE OF \$100 EACH YEAR. THIS WOULD ALLOW THE ESTABLISHMENT THE RIGHT TO HAVE ITS PATRONS PLAY PARLAY CARDS UNDER MY LOTTERY TICKET DISPENSOR METHOD OR FIVE OTHERS, WITH THE OHIO LOTTERY COMMISSION UNDER MY OVERALL SUPERVISION. YOU HAVE TO HAVE ONE OVERSEER OF THE PROGRAM, IT MIGHT AS WELL BE ME, THE ORIGINAL INVENTOR OF THE PROGRAM TO BEGIN WITH.

THE PATRONS WOULD MAKE THEIR SELECTIONS FROM THE MASTER PARLAY CARD PUBLISHED ON THE "bet.OHIO.com" WEBSITE (SEE EXHIBIT ONE), AND MAIL THEM IN (E-MAIL ON FRIDAYS OR ON SATURDAYS FOR "PRO-ONLY" TICKETS) TO THE CENTRAL PROCESSING CENTER FOR DISPOSITION. THE ESTABLISHMENT WILL TAKE IN ALL CASH WAGERS, KEEP FIVE PERCENT OF GROSS, (05%), AND THEN SEND IN ONE LARGE CHECK FOR 95% OF GROSS TO THE LOTTERY COMMISSION AND MY CENTRAL PROCESSING CENTER, CREATING 100 NEW JOBS TO START AND MORE AS NEEDED.

WINNERS WILL THEN SEND IN A THIRD COPY TO THE CENTRAL PROCESSING CENTER FOR PAYMENT. THIS WILL KEEP THE ENTIRE SYSTEM ONE WEEK AHEAD ON CASH-FLOW AND SETTLEMENTS, ELIMINATING THE "RISK" FACTOR THAT YOU UNFORTUNATELY OVERPLAYED IN YOUR PRESS CONFERENCE LAST THURSDAY. THERE IS NO RISK WHATSOEVER WITH THIS SYSTEM, AS WILL BE EXPLAINED IN THE FOLLOWING SECTION.

ELIMINATION OF RISK FACTORS:

MY ORIGINAL PROPOSAL CALLED FOR THE LOTTERY COMMISSION TO TAKE IN, GRADE AND PAYOUT ALL BETS BY WAY OF THE SYSTEM, CREATING A \$750 MILLION PER YEAR PROFIT ON A \$5 BILLION PER YEAR GROSS, AND YES THERE WOULD HAVE BEEN A SLIGHT BIT OF RISK INVOLVED, BUT THAT RISK WAS ONLY ON THE STRAIGHT BET SIDE, NOT THE PARLAY CARD SIDE. THERE IS ABSOLUTELY NO RISK WHATSOEVER TO A PARLAY CARD OPERATION, NO MATTER HOW LARGE OR HOW SMALL.

THE BEAUTY OF THIS NEW PLAN AND WHAT WAS MY "COMPROMISE PLAN" TO BEGIN WITH, IS THAT IT TAKES ANY RISK COMPLETELY OFF THE LOTTERY COMMISSION AND THE TAXPAYERS WHICH YOU CALLED "THE BANK OF LAST RESORT" IN THE PRESS CONFERENCE AND SHIFTS IT TOTALLY TO ALL THE CLASS "A" AND CLASS "B" LICENSEES.

MY ORIGINAL "COMPROMISE PLAN" CALLED FOR THE SEPARATION OF WAGERS AT THE PARLAY CARD. THE CASINO INDUSTRY WOULD BE RESPONSIBLE FOR ALL STRAIGHT BETS, SINGLE OVER/UNDERS, TEASERS, FUTURES AND THE "PROPOSITION BETS" YOU SEEMED TO BE OVERLY ENAMORED WITH. THE OHIO LOTTERY COMMISSION WOULD THEN BE RESPONSIBLE FOR ALL PARLAY CARDS, AND THE TRUTH BE TOLD, THAT'S ALL I WANTED TO DO IN THE FIRST PLACE WAS RUN THE PARLAY CARD FOR THE STATE OF OHIO BY WAY OF THE LOTTERY COMMISSION'S 10,000+ LOTTERY TICKET DISPENSER TERMINALS.

AND NOW YOU HAVE IT. OR AT LEAST YOU WILL AND THE EXTRA \$300-\$400 MILLION IT WILL PROVIDE THE SCHOOLS SYSTEM (AND THE RETAILS) IF YOU APPROVE AND INCLUDE MY "CLASS "C"" LICENSE PLAN.

MY LITTLE OPERATION BACK IN THE DAY THAT RAISED \$50,000 PER YEAR FROM FOUR SMALL BARS IN WHITEHALL AND GOT ME THROUGH COLLEGE (IF YOU WANT TO KNOW HOW LUCRATIVE THIS CLASS "C" SYSTEM CAN BE) PROVES THERE IS NO RISK WHATSOEVER. IN OVER 300+ WEEKS, I HAD ONLY TWO NEGATIVE ONES, (THAT IS LESS THAN 01%), AND BOTH WERE COVERED BY THE CASH RESERVE I HAD BUILT-UP IN ADVANCE. THEY ALSO COULD HAVE BEEN COVERED BY MY NEXT WEEK'S INTAKE, AS DESCRIBED ABOVE AND WHAT IS PROPOSED UNDER THE CLASS "C" SYSTEM, BUT THERE WAS NO NEED.

QUITE FRANKLY, THERE IS NO NEED FOR THE CLASS "C" SYSTEM TO DO IT THAT WAY EITHER; I ONLY INTRODUCE IT TO ASSUAGE YOUR FEARS ABOUT USING THE TAXPAYERS AS THE "BANK OF LAST RESORT". IN ANY EVENT, THOSE ARE DETAILS THAT CAN BE WORKED OUT AT ANY TIME IN THE FUTURE PROCESS. THE IMPORTANT THING, MR. CHAIRMAN, IS DO YOU WANT THE EXTRA \$300-\$400 MILLION THE CLASS "C" SYSTEM WILL PROVIDE OR NOT? SINCE THESE FUNDS TRIPLE OR QUADRUPLE WHAT WILL GO TOWARD THE SCHOOL SYSTEM (SEE EXHIBIT 02), I HOPE YOUR ANSWER, IS A RISK-FREE, ROBUST AND RESOUNDING "YES".

GAME-FIXING:

THIS IS WHY I THINK, WITH DUE RESPECT TO OUR SPORTS TEAMS, THAT IT IS A VERY BAD IDEA TO ALLOW THEM INTO THE CLASS "A" OR CLASS "B" SYSTEM. YOU ARE LETTING THE FOX INTO THE HEN HOUSE.

THERE ARE FOUR WAYS TO FIX A GAME:

01. THROUGH A PLAYER OR PLAYERS
02. THROUGH A REFEREE OR REFEREES
03. THROUGH A SMALL MARKET COACH NOT GETTING "NICK SABAN MONEY"
04. AND FINALLY, I HATE TO SAY IT, THROUGH MANAGEMENT.

I HAVE INCLUDED EXAMPLES OF ITEMS 02 AND 03 ABOVE (SEE EXHIBITS 03 AND 04) AND I HOPE ITEM 01 BECOMES A MOOT POINT WITH THIS IMPENDING COLLEGE "FREE-AGENCY" THAT IS CURRENTLY ON THE TABLE NATIONWIDE, BUT AS TO ITEM #04, MANAGEMENT (OR OWNERSHIP), PLEASE CONSIDER THE FOLLOWING HYPOTHETICAL SCENARIOS:

I AM NOT SAYING THE OWNERS OR MANAGEMENT OF ANY OF OUR OHIO SPORTS FRANCHISES WOULD EVER DO THIS, I AM JUST SAYING THAT BY GRANTING THEM A CLASS "A" OR CLASS "B" LICENSE, THE POTENTIAL IS THERE. AS SUCH, OWNERS AND MANAGEMENT SHOULDN'T BE WITHIN A HUNDRED MILES OF A SPORTSBOOK, MUCH LESS OWN ONE! THE POTENTIAL AND PERHAPS EVEN THE NECESSITY TO FIX A MATCH AS OUTLINED BELOW IS JUST TOO OVERWHELMING, ESPECIALLY IF THE OWNER AND "THE BOOKIE" ARE THE SAME PERSON, AND THEY ARE HEAVY ON ONE SIDE!

BASEBALL:

LET'S SAY THE OVER/UNDER ON AN INDIANS OR REDS GAME IS 07.

IT IS THE 7TH INNING AND WE ARE ALREADY ON FIVE. SINCE THE OWNER OF THE TEAM AND THE OWNER OF THE BOOK ARE THE SAME PERSON, THE CONVERSATION MIGHT GO LIKE THIS (IN THE CALL DOWN FROM THE SKYBOX):

"COACH" . . ."

"YES" . . ."

"THE OWNER HERE . . . I WANT AT LEAST TWO STRIKE-OUTS "BY LOOKING" PER INNING UNTIL THE END OF THE GAME. I GOT \$2 MILLION OF THE PUBLIC'S MONEY ON THE OVER AND I COULDN'T LAY-IT-OFF BECAUSE EVERY ONE ON THE PLANET FROM VEGAS TO PEORIA IS ALSO ON THE OVER, SO YOU KNOW WHAT TO DO . . ."

"YES, SIR . . ."

"GET IT DONE AND THERE WILL BE A LITTLE EXTRA IN YOUR CHRISTMAS STOCKING THIS YEAR . . . "

"YOU GOT IT . . ." AND THEY BOTH HANG UP.

IT'S THAT SIMPLE. IN FACT, IT'S A SIMPLE, SINGLE PHONE CALL.

FOOTBALL:

LIKEWISE, LET'S SAY THE BROWNS OR THE BENGALS HAVE JUST SCORED A LAST MINUTE TOUCHDOWN TO GO AHEAD 26-20 (AND THE LINE IS SEVEN) . . . HERE COMES THE CALL DOWN FROM THE LUXURY BOX:

"COACH . . . YOU'RE GONNA GO FOR TWO ON THIS ONE AND MUFF IT!!"

"YES SIR" . . . HEY, MAYFIELD, GET OVER HERE . . . BOOTLEGG 14, MUFF IT AND MAKE IT LOOK GOOD!!"

"BUT, COACH, I SCORE ON THAT ONE ALL THE TIME . . ."

"JUST DO IT, O.K., NUMB NUTTS, MY CONTRACT IS ON THE LINE THIS YEAR!"

"O.K., COACH, YOU OWE ME ONE"

AFTER THE GAME, REPORTERS ASK THE COACH, "COACH, WHY DID YOU GO FOR TWO THERE AT THE END OF THE GAME, IT SEEMED UNNECESSARY."

COACH: "WELL THERE WAS A MINUTE LEFT AND WE DIDN'T WANT THEM TO COME DOWN AND TIE IT UP TO GO INTO OVERTIME."

REPORTERS: "WHAT ABOUT ALL THOSE PEOPLE WITH THE BROWNS -07?"

COACH: "IS IT MY JOB TO WIN THEM MONEY, OR INSURE THAT WE WIN THE GAME? GOING FOR TWO WOULD HAVE INSURED THIS, BECAUSE AT AN EIGHT POINT DIFFERENTIAL WE HAVE A BETTER CHANCE OF WINNING. BAKER JUST FELL SHORT, THAT'S ALL."

YOU SEE, AND THE PUBLIC WOULD NEVER KNOW ABOUT IT. IN THE MOVIES AND IN WASHINGTON, THE CALL IT "PLAUSIBLE DENIABILITY".

AGAIN, THESE TWO SCENARIOS ARE HYPOTHETICAL AND I AM NOT SAYING ANY PROFESSIONAL FRANCHISE OWNER IN ANY LEAGUE OR SPORT WOULD DO THIS, I AM SAYING AND ILLUSTRATING IS THAT WITH A CLASS "A" OR CLASS "B" LICENSE IT IS POSSIBLE, AND YOUR GRANTING EITHER LICENSE MAKES IT POSSIBLE.

THE UNFORTUNATE REALITY IS GAME-FIXING HAPPENS ALL THE TIME, BY MANY, MANY, DIFFERENT METHODS THAT THE PUBLIC WILL NEVER DETECT. I HAVE OUTLINED THE FOUR MAJOR WAYS AND AN EXPERIENCED GAMBLER LIKE ME, WITH MONEY ON A GAME CAN DETECT ANY OF THEM. UNLIKE THE PUBLIC, WITH MONEY ON A BIG GAME I CAN SEE A COCKROACH POLL-VAULT OVER THE 50 YARD-LINE. MOST OF THE PUBLIC CAN NOT.

THE RULE OF THUMB - AND YOU CAN SEE IT VIVIDLY IN EXHIBITS 03 AND 04 - IS THAT ANYTIME YOU SEE A CALL, OR A PLAY OR SOMETHING RELATIVELY STRANGE OR UNORTHODOX THAT DOESN'T AFFECT THE FINAL OUTCOME OF THE GAME, BUT AFFECTS GREATLY THE POSTED SPREAD, YOU CAN CORRECTLY ASSUME THAT PARTICULAR GAME MIGHT BE FIXED.

THAT'S WHY THEY CALL IT POINT "SHAVING" BECAUSE THEY ARE NOT REALLY TRYING TO DETERMINE WHO WINS OR LOSES THE GAME, JUST TRYING TO STAY EITHER BELOW OR ABOVE A CERTAIN NUMBER DEPENDING NATIONWIDE WHO IS "HEAVY" ON ONE SIDE OR THE OTHER AFTER MAJOR LAY-OFFS HAVE CONCLUDED.

IF YOU WANT TO STOP ALL THIS LIKE A BUS RUNNING INTO A WALL THERE IS A SIMPLE AND SINGLE SOLUTION (AND YOU HAVE THE OPPORTUNITY TO SHOCK THE WORLD BY WRITING IT INTO THE LEGISLATION):

LIE-DETECTOR TESTS

WEEKLY LIE-DETECTOR TESTS AND/OR ONE BEFORE AND/OR AFTER THE GAME FOR THE REFS, COACHES AND OWNERSHIP. I WOULDN'T RECOMMEND IT FOR THE PLAYERS AS I TRUST THEIR AMATEUR STATUS MORE, AND THIS FREE AGENCY FOR YOUNG STARS MIGHT ELIMINATE MOST OF IT.

REVENUE FROM BEYOND OUR BORDERS:

I DIDN'T HEAR ANYTHING IN YOUR PRESENTATION ON THURSDAY, MR. CHAIRMAN, THAT WOULD EITHER ALLOW OR PRECLUDE THIS, SO I GUESS IT IS STILL ON THE TABLE?

AGAIN, I HAVE THE TWO FOLLOWING NEW PRODUCTS THAT WILL MAKE US ADDITIONAL BILLIONS FROM BEYOND OUR BORDERS - IF PATENTED. WE ARE NOT ALLOWED TO IMPLEMENT THE PRODUCTS OURSELVES DUE TO THIS GEO-NETTING NONSENSE THAT NOW EXISTS, BUT THERE IS ABSOLUTELY NOTHING LEGALLY THAT PRECLUDES US FROM LICENSING THE TWO PRODUCTS - ONCE PATENTED - TO EVERYONE ELSE ON THE PLANET.

ENCLOSED AGAIN IS MY PRO-FORMA (EXHIBIT #05) OF PRODUCT #01, MY "NEW BET FOR WOMEN", GIVEN TO THE OHIO STATE UNIVERSITY. I KNOW GIVE IT TO YOU FOR YOUR REVIEW. IT REALIZES AN EXTRA \$142 MILLION IN LICENSING FEES, MATCHING OR EVEN EXCEEDING WHAT THE STATE WILL TAKE-IN ON YOUR CLASS "A" AND CLASS "B" LICENSES. PLEASE NOTE, HOWEVER, THAT I USE THE TERM "BILLIONS" BECAUSE THIS LITTLE PRO-FORMA ONLY COVERS 01 OF THE 09 POTENTIAL SEGMENTS

OF THE MARKET. (AND QUITE FRANKLY, ONLY HALF OF THE INITIAL (#01) MARKET, MAKING ITEM #01 (ONLY) WORTH ANOTHER \$250-\$300 MILLION IN UP-FRONT LICENSING FEES AND WHATEVER THE 10% OF GROSS EARLY ROYALTIES WILL RAISE.) SINCE, WHEN ALL THE ATHLETICS DIRECTORS REALIZE THAT THE "VIG" (PROFIT MARGIN) ON THIS NEW BET APPROACHES 80-90%, THEY WILL BE ONLY TOO HAPPY TO PAY US \$1.00 PER SEAT AND 10%/YR THEREAFTER, AS THEY WILL KEEP 70-80%.

AS TO PRODUCT #02 PLEASE NOTE THE YELLOW-LINED ITEM IN EXHIBIT #05 AND ALSO THE SECTION BELOW ON HOW MANY MAJOR STATES, INCLUDING OUR OWN THAT FOR ONE REASON OR ANOTHER ARE GOING TO MISS THIS YEAR'S COLLEGE AND PROFESSIONAL FOOTBALL SEASONS.

LOTTERIES ACROSS THE COUNTRY ARE TRYING TO FIGURE-OUT HOW TO TURN THEIR TERMINALS INTO SPORTS-BETTING STATIONS AND ARE COMING-UP SHORT. THAT IS BECAUSE THE TERMINALS SHOULD BE "CASH COLLECTION STATIONS", NOT SPORT-WAGERING MACHINES. IF WE PATENT PRODUCT #02 - EVEN THOUGH THE LOTTERY COMMISSION HAS GIVEN MY INVENTION TO INTRALOT - THEN WE CAN MEET WITH THE GOVERNORS OF THE "OTHER 48" AND ILLUSTRATE TO THEM THAT IF THEY UTILIZE THE SYSTEM CORRECTLY AND PAY US A 10% ROYALTY FOR ITS USE, THEN THEY WILL MAKE TEN TIMES THE REVENUE THEY ARE MAKING NOW, BY ERRONEOUSLY, UNKNOWINGLY FARMING IT OUT TO THE CASINOS.

WHAT ARE THEY GOING TO SAY "NO", FOOLISHLY AS WE HAVE IN OHIO, TO THE EXTRA 09X, BECAUSE MAKING AN EXTRA \$750 MILLION FOR OUR SCHOOLS IS "RISKY"? IF IT IS THAT "RISKY" HOW ARE TWO OTHER STATES DOING IT AND DOING IT WELL? MINUS THE POLITICS, THEY WILL SAY "YES"!

EMERGENCY PROPOSAL(S) :

ONE NEWS ACCOUNT OF YOUR PRESENTATION STATES THAT EVEN IF THE LEGISLATION IS APPROVED FORTHWITH, THAT OPERATORS MAY NOT BEGIN UNTIL JAN 01, 2022, EVEN THOUGH LEGISLATION WILL BE DONE IN JUNE?

I DIDN'T HEAR YOU SAY THAT, BUT IF IT IS TRUE, THAT MEANS WE WILL MISS THIS YEAR'S COLLEGE AND PROFESSIONAL FOOTBALL SEASONS (SPORTS-WAGERING FISCAL YEAR 04) WHEN THE LION'S SHARE OF SPORTS-WAGERING TAKES PLACE AS DO THE RESULTANT BILLION\$.

EITHER WAY, ENCLOSED (AS EXHIBIT #06) IS MY EMERGENCY PROPOSAL TO THE SIX OTHER KEY STATES AND OHIO (AND CANADA) THAT MAY MISS THE SEASONS, SO YOU WON'T LOSE THE BILLIONS TO BE MADE FROM NOW UNTIL JANUARY 01, WHILE ALL THESE CARPETBAGGERS ARE BUILDING THEIR CLASS "B" - UNNECESSARY BUT GRATEFUL - BRICKS-AND-MORTER SPORTSBOOKS UNDER YOUR "FREEMARKET-40" NEW SYSTEM.

IN CONCLUSION:

MR. CHAIRMAN, I HAVE ALWAYS SAID "WHY SELL THE COW, WHEN YOU ARE GETTING THE MILK FOR FREE." I DON'T UNDERSTAND WHY, BUT YOU HAVE DONE EXACTLY THAT. PERHAPS YOU WERE MESMERIZED ON YOUR TRIP TO THE LAST SPORTS BOOK REGARDING "PROPOSITION BETS" AND I DON'T UNDERSTAND THAT EITHER BECAUSE PROP BETS ARE SEXY IF MADE IN-GAME, BUT QUITE FRANKLY ARE LAST ON THE LIST AS FOLLOWS:

01. STRAIGHT BETS, COLLEGE AND PRO FOOTBALL
02. PARLAY CARDS, COLLEGE AND PRO FOOTBALL
03. THE OVER/UNDER - PRO ONLY
04. THE OFF SEASON - ALL OTHER WAGERS
05. PROPOSITION BETS, TEASERS, FUTURES, IN-GAME. ETC.

I, MYSELF, WOULDN'T SPEND A DIME ON "PROPS" AS EITHER AN OPERATOR OR A GAMBLER, BUT YOU HAVE BASED YOUR ENTIRE CLASS "B" PROPOSAL ON IT. YOU WON'T MAKE MUCH SPORTS-WAGERING THERE AS MORE PEOPLE THAN JUST MYSELF HAVE TESTIFIED TO THE 85/15 SPLIT BETWEEN ON-LINE AND PHYSICAL PRESENCE BETS, (AND MOST CASINOS WILL ALSO TELL YOU SPORTS BETTING IN GENERAL IS A "LOSS-LEADER" TO GET PEOPLE INTO THE CASINO'S TO PLAY THEIR HIGHER-MARGIN TABLE GAMES) BUT WE WILL TAKE THE BILLIONS IN PHYSICAL PROPERTY DEVELOPMENT, JOBS, TAXES AND SPIN-OFF DEVELOPMENT THE CLASS "B" PROGRAM WILL PROVIDE. AND TO THAT, AGAIN, I COMMEND AND APPLAUD YOUR EFFORTS AS SENATE FLOOR LEADER, AND YOUR COLLEGES ON THE COMMITTEE AS LEGISLATORS.

HAVING SAID THAT, I SINCERELY HOPE - AGAIN - THAT YOU WILL NOT THROW THE BABY OUT WITH THE BATHWATER AND ALLOW ME TO BRING HALF OF THE \$750 MILLION YOU HAVE LOST BACK TO THE SCHOOL SYSTEM BY WAY OF MY CLASS "C"TM INVENTION AND ITS UTILIZATION IN MY ORIGINAL "THE STATE AS THE HOUSE"TM PROGRAM.

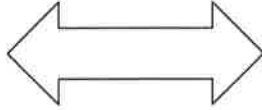

TO BEGIN WITH THE LINE OPENED AT -23.5 AND FELL CONSISTENTLY THROUGHOUT THE DAY, -22.0, -21.5, -21.0 AND FINALLY SETTLED DOWN AT -20.5, THREE FULL POINTS DOWN FROM THE OPENER. I CALLED A FRIEND OF MINE, AND SAID, "WHAT'S UP, *SOMEBODY DIE?*" HE SAID, "I DON'T KNOW, I'M LOOKIN AT THE SAME GAME BECAUSE IT WAS ATTRACTIVE AT 23.5 EVEN - THE FIX MUST BE IN." I SHOULD HAVE LISTENED TO HIM, BUT I TOOK THE THREE-POINT CUSHION BECAUSE THIS TEAM WAS 9-0 AND ON FIRE WITH A SUPER-QUARTERBACK AND HAD COVERED MY NUMBER IN SEVEN OF THE LAST NINE GAMES.

IT WAS A SMALL SCHOOL AND THE COACHES SALARY WAS \$450,000, CONSIDERED VERY HIGH FOR THAT TIME AND THAT CONFERENCE, BUT WAS'T URBAN MEYER OR NICK SABAN MONEY AT #6-\$7 MILLION WAS IT? SO IF SOMEONE COMES BY AND WHISPERS THE FOLLOWING IN YOUR EAR OR IN THE EAR OF A COACH MAKING LESS THAN A MILLION EVEN:

"KEEP IT UNDER 20 AND YOU GOT 100 LARGE COMIN'"

WHAT ARE YOU GOING TO SAY "NO"? WHEN IT IS A ONE-TIME TAX-SHELTERED PAYMENT IN CASH THAT EXCEEDS 50% OF YOUR TAKE-HOME PAY? (FOR THOSE THAT DON'T KNOW "100 LARGE" = \$100,000).
