TESTIMONY OF RICHARD OHANIAN BEFORE THE SELECT COMMITTEE ON GAMING

RE: SB-176 --- MAY 26, 2021

INTRODUCTION

THANK-YOU CHAIRMAN SCHURING, VICE-CHAIRMAN MANNING AND SELECT COMMITTEE MEMBERS FOR ALLOWING ME TO TESTIFY TODAY. WITH DUE RESPECT TO EVERYONE INVOLVED THIS BILL, SENATE BILL 176, IS AN ABSOLUTE DISASTER FOR THE STATE OF OHIO, ITS SCHOOL SYSTEMS, ALL THE SMALL RETAILERS WHO HAVE TESTIFIED THUS FAR, AND ECONOMIC DEVELOPMENT IN GENERAL.

THE FOUR EXISTING PLANS

THERE SEEMS TO BE FOUR PLANS ON THE TABLE AT PRESENT, MY ORIGINAL "THE STATE AS THE HOUSE" PROGRAM, MY ORIGINAL "COMPROMISE" PLAN SUBMITTED IN FEBRUARY, THE ORIGINAL HB-194/SB-111 PLAN AOF LAST YEAR AND THE CURRENT SB-176 PLAN. THE COMPARATIVE YEARLY FUNDING AMOUNTS TO EACH MAJOR PARTY, THE SCHOOLS SYSTEMS AND THE CASINO INDUSTY ARE LISTED BELOW:

IN PLANS #01 AND #02 ALL THE LITTLE RETAILERS SUCH AS GROCERY STORES, CONVENIENCE MARTS, BOWLING ALLEYS, BARS AND RESTUARANTS BENEFIT GREATLY. IN PLANS #03 AND #04, THESE SMALL RETAILERS RECEIVE LITTLE OR ABSOLUTELY NO BENEFIT, QUASHING ADDITIONAL AND LOCAL "NEIGHBORHOOD" TYPE OF DEVELOPMENT TOTALLY, IN DEFERENCE TO LARGE CORPORATE "ANCHOR-PROJECT" TYPE CARPETBAGGING OF THIS COMMITTEE'S "FREE-MARKET-40" PLAN.

DERELICTION OF DUTY

IN SUCH A CASE, ONE WONDERS WHO THE COMMITTEE IS MORE BEHOLDEN TO THE CASINO INDUSTRY OR OUR SCHOOL CHILDREN AND LOCAL RETAILERS BECAUSE SB-176 OBVIOUSLY GIVES THEM THE SHORT END OF THE STICK, AND BY A FACTOR OF TEN!

THE LEGAL CHARGE OF THIS COMMITTEE IS SIMPLY TO APPROVE SPORTS-WAGERING OR DISAPPROVE IT, NOT TO DECIDE INTO WHOSE POCKETS THE MONEY WILL FLOW, ESPECIALLY BY UNCONSITUTIONAL LEGISLATION (WHICH WILL BE DISCUSSED AT LENGTH LATER IN THIS PAPER). ANYTHING ELSE CONSTITUTES TOTAL DERELICTION OF DUTY AND COMPLETE LACK OF RESPONSIBILITY TO THE SCHOOL SYSTEM AND THE TAXPAYER, AND THE INSPECTOR GENERAL OF OHIO SHOULD BE INVESTIGATING THIS TRAGEDY, GIVEN THE COMPARATIVE DOLLAR AMOUNTS IN QUESTION.

ECONOMIC DEVELOPMENT

THE CASE HAS BEEN MADE BY THIS COMMITTEE THAT THE CLASS "B" LICENSE PLAN WILL ADD HUNDREDS OF MILLIONS OF DOLLARS IN ECONOMIC DEVELOPMENT TO THE STATE BY THE CONSTRUCTION OF TWENTY NEW "BRICKS-AND-MORTER" SPORTSBOOK FACILITIES. THIS IS TRUE ON THE SURFACE OF THE PROPOSAL, BUT I WONDER IF THE COMMITTEE HAS LOOKED DEEPER INTO THE ACTUALLITY, IN OTHER WORDS, THE DOLLARS THAT WILL EXIT THE STATE IN DEEP-SOUTH, CARPET-BAGGER FASHION.

NOT A SINGLE ONE OF THESE LARGE GAMING COMPANIES HAS A HOME OFFICE IN OHIO, NOT INTRA-LOT, NOT MGM GRAND, NOT PENN NATIONAL, NOT FOX-BET, NOT WYNN RESORTS, NOT THE LAS VEGAS SANDS, NO ONE. SO EVEN THOUGH THE BILL CALLS FOR THEM TO HAVE AN "OHIO PRESENCE", IT DOES NOT REQUIRE THEM TO KEEP THE LION'S SHARE OF PROFITS IN THE STATE, ESCPECIALLY IF THEY ARE A PUBLIC COMPANY RESPONSBILE TO THEIR OWN STOCHOLDERS.

THUS, UNDER SUCH A SCENARIO, THERE MAY BE MORE DOLLARS EXITING THE STATE, THAN FLOWING INTO IT. A SIMPLE ECONOMIC STUDY SHOULD BE COMPLETED BEFORE THIS BILL IS PASSED TO DETERMINE WHETHER THE INVOLVEMENT OF THE CARPETBAGGERS WILL BE A NET GAIN FOR THE OHIO ECONOMY OR A NET LOSS. AT LEAST MY TWO PLANS WILL KEEP ALL THE MONEY IN THE STATE FOR ECONOMIC DEVELOPMENT SUCH AS THE CONSTRUCTION OF NEW SCHOOL BUILDINGS & NEIGHBORHOOD DEVELOPMENT.

THE POSITIVE SIDE OF THE CLASS "B" SYSTEM IS, YES, THESE BUILDINGS WILL BE CONSTRUCTED CREATING A TEMPORARY CONSTRUCTION BOOM. DUE TO THE 85/15 SPLIT BETWEEN ON-LINE AND PHYSICAL PRESENCE WAGERS, HOWEVER, THESE BUILDINGS MAY VERY WELL BE EMPTY AFTER THEY OPEN, BUT AT LEAST A BOATLOAD OF CONSTRUCION WORKERS WILL HAVE JOBS AND FOOD ON THE TABLE FOR A YEAR OR TWO.

MY TWO PLANS AND THE "RISK" FACTOR

TO NEGATE THE POSITIVE FORCE OF MY "THE STATE AS THE HOUSE" PLAN, THIS COMMITTEE MADE THE FOLLOWING THREE STATEMENTS:

- 01. "TOO MUCH RISK . . ."
- 02. "WE WILL NOT PUT THE TAXPAYERS IN THE POSITION OF BEING THE BANK-OF-LAST-RESORT" AND:
- 03. "A LOTTERY IS A LOTTERY . . . "

LOOKING INTO THESE STATEMENTS PER THE FOLLOWING, WE FIND THESE STATEMENTS ARE NOTHING MORE THAN "CNN-LIKE", "FAKE NEWS", SPIN-DOCTORING THAT WILL NEGATE BILLIONS OF DOLLARS OF ACTUAL STATE-WIDE ECONOMIC DEVEOPMENT IN FAVOR OF A HOOVER-VCCUUM EFFECT THAT WILL NEGATIVELY IMPACT THE STATE AND ITS SCHOOLS SYSTEM AND NEIGHBORHOODS, FOREVER.

AS TO THE RISK OF MY ORIGINAL PLAN, YES THERE IS A SLIGHT RISK, BUT YOU HAVE TO ASK YOURSELF IS IT WORTH THE RISK TO RAISE THE \$7.5-\$15.0 BILLION ANTICIPATED OVER THE NEXT DECADE. THE ANSWER IS "YES" AND I BELIEVE THIS "RISK FACTOR" IS BEING PURPOSEFULLY OVERSTATED AS FOLLOWS: (ODDLY ENOUGH, THE CLASS "B" LICENSE HAS TOTALLY NEGATED THIS NOTION OF RISK FOR THE "COMPROMISE PLAN" - WHICH WILL BE DISCUSSED IN A LATER SECTION OF THIS PAPER - AS IF THERE WAS ANY RISK AT ALL TO MY ORIGINAL PLAN, IT WAS TOTALLY ON THE "STRAIGHT BET" SIDE, NOT THE PARLAY CARD SIDE.

01. IF THE RISK WAS AS LARGE AS DESCRIBED BY THE COMMITTEE, THEN LAST VEGAS WOULD STILL BE A DESERT SANDLOT INSTEAD OF A SHINING. SHIMMERING CITY AND ONE OF THE LARGEST TOURIST ATTRACTIONS IN THE WORLD. THE ODDS ARE SACROSANCT AND ARE THE SINGLE DETERMINANT FACTOR IN THIS INDUSTRY, NOT FALSE, OVER- BLOWN SPIN-DOCTORED STATEMENTS ABOUT NON-EXISTENT "RISK".

- 02. IF THIS NOTION OF RISK IS AS LARGE AS DESCRIBED BY THE COMMITTEE, THEN WHY ARE 40 CLASS "A" AND CLASS "B" OPERATORS WILLING TO FORFEIT THE SUM OF \$1,000,000 AND MORE MILLIONS IN THE REQUIRED CONSTRUCTION OF "BRICKS-AND-MORTAR" TO PARTICIPATE? WHAT ARE THEY PURCHASING FOR THEIR INVESTMENT, HORRID RISK, OR THE CHANCE TO SHARE IN A \$7.5-\$15.0 BILLION MARKET OVER THE NEXT DECADE?
- 03. IF THIS RISK IS AS LARGE AS THE COMMITTEE DESCRIBES THEN WHY HASN'T A SINGLE ONE OF THE 18 REPORTING STATES AND THEIR OPERATORS REPORTED A SINGLE NEGATIVE MONTH IN THE LAST 03 YEARS OF OPERATION SINCE THE SUPREME COURT MADE THEIR DECISION? ENCLOSED AS EXHIBIT #01 IS THE "YEAR TO DATE" FIGURES FROM 2018 TO THE PRESENT DAY (MINUS A MONTH OR TWO DUE TO REPORTING STATUTES). AS YOU CAN SEE THERE HASN'T BEEN A SINGLE NEGATIVE MONTH IN THREE YEARS, AND THIS IS IN THE MIDDLE OF A WORLDWIDE PANDEMIC!!

ANY OF THE "X's" SHOWN AFTER A STATE HAS COMMENCED OPERATIONS ARE COVID-RELATED SUSPENSIONS, NOT GAMBLING LOSSES, SO THAT IS APPROXIMATELY 648 MONTHS OF POSITIVE HANDLE, POSITIVE PROFIT, AND ALSO POSITIVE TAXES COLLECTED AND 000 MONTHS OF NEGATIVITY. WITH DUE RESPECT TO THIS COMMITTEE WHERE IS THIS "RISK" WHATSOEVER ON \$53 BILLION+ RAISED FROM JUST 18 STATES THUS FAR??!!

04. INSURANCE COMPANIES ARE BUSINESS OF MANAGING IN THE "RISK"; DO YOU SEE ANY OF THEM GOING BROKE ANYTIME SOON? NO, IN FACT, THEY ARE SO WEALTHY, THEY HAVE TO BUILD A HIGH-RISE BUILDING EVERY FEW YEARS, JUST TO UTILIZE SOME OF THE FUNDS THE HAVE ON HAND. IF THE TRUTH BE TOLD, AN INSURANCE COMPANY IS JUST A BIG, VERTICAL PARLAY CARD, WITH PLUSES ON ONE SIDE AND MINUSES ON THE OTHER. THE SUCCESS OF INSURANCE COMPANIES AND THE FACT PARLAY CARDS ARE KNOWN IN THE INDUSTRY AS "A LICENSE TO PRINT MONEY" (AT 25-30% PROFIT), THERE IS ABSOLUTELY NO RISK IN MY COMPROMISE PLAN WHATSOVER. MOREOVER, AND WHAT CAN ONLY BE CONSIDERED AS POETIC JUSTICE, MR CHAIRMAN, IS THAT THE CLASS "B" SYSTEM HAS ELIMINATED THIS RISK TOTALLY FROM THE COMPROMISE PLAN.

- O5. THE COMPROMISE PLAN CALLED FOR THE DIVISION LINE AT THE PARLAY CARD. THE STATE LOTTERY, UNDER MY DIRECTION WOULD TAKE-IN, GRADE AND PAY-OUT ALL THE PARLAY CARDS AND THE CASINO INDUSTRY WOULD BE RESPONSIBLE FOR ALL OTHER BETS AND THE RESULTANT ASSOCIATED RISK. HENCE NO RISK WHATSOEVER TO THE STATE OR RETAILERS FROM PARLAY CARDS.
- 06. FINALLY, IF THIS RISK FACTOR IS AS BIG AS DESCRIBED, I WOULDN'T HAVE GOTTEN THROUGH COLLEGE. MY OWN LITTLE PARLAY CARD OPERATON BACK-IN-THE-DAY WAS A 50% PROFIT (AS I HAD NO OVERHEAD EXCEPT MY OWN TIME) ON A \$50,000/YR GROSS FROM 04 SMALL BARS IN WHITEHALL. ALSO, IN 300+WEEKS OF OPERATION, I HAD TWO NEGATIVE WEEKS. IN OTHER WORDS LESS THAN ONE-PERCENT, (01%). BOTH WERE COVERED BY THE CASH RESERVE I HAD BUILT-UP AT THE TIME. THEY COULD ALSO HAVE BEEN COVERED BY THE NEXT WEEKS INTAKE, A TACTIC THAT IS AN ADDITIONAL SAFEGURD TO BE UTILIZED ONLY WHEN NECESSARY IN MY COMPROMISE (AND RETAILER) PLAN.

MR. CHAIRMAN, YOU MADE THE FOLLOWING STATEMENT AT YOUR PRESS CONFERENC A FEW WEEKS AGO:

"... there were some who came in an suggested, well, we can do a variation of the lottery and we'll bank the bets... you know who is the bank of last resort? the people of Ohio ... and we're not gonna' put the people of Ohio at risk ..."

LET'S LOOK A BIT DEEPER INTO THAT FROM TWO RESPECTS. FIRST, IF WE REALLY ARE GOING TO TAKE \$7.5 TO \$15.0 BILLION OUT OF THE SCHOOLS SYSTEM AND GIVE IT - BY STATUTE NO LESS - TO A PRIVATE INDUSTRY, THEN WITH RESPECT, WHO BECOMES THE "LAST RESORT FOR THE SCHOOL MILLAGE LEVIES OF THE FUTURE" IF NOT THE TAXPAYER??!!

THIS SPORTS-WAGERING THING WOULD HAVE PROVIDED THE FUNDS THAT WOULD EITHER REDUCE OR NEGATE ANY FUTURE SCHOOL LEVIES IN THE STATE AND THAT IS WHAT THIS SPORTS-WAGERING THING WAS SUPPOSED TO DO, IF YOU BELIEVE THE SAME LANGUAGE THAT SUPPORTS IF YOU TAKE THAT AWAY, THEN WITH RESPECT, MR. SO CHAIRMAN, YOU AND THE COMMITTEE ARE MAKING THE TAXPAYER THE BANK OF LAST RESORT (FOR THE SCHOOL SYSTEM). AS A RESULT YOU SHOULD CONSIDER REVERSING DIRECTION IMMEDIATELY TO A SYSTEM THAT WILL SYSTEM MORE FUNDS THAT THEY EVER THE SCHOOL GIVE POSSIBLE OT ONLY FOR THE NEXT DECADE, BUT EVERY ONE THEREAFTER.

SECOND, AS TO THE TAXPAYERS BEING THE "BANK OF LAST RESORT" WITH REGARD TO SPORT WAGERING "RISK", WITH RESPECT, ISN'T AN OVERAGE IN THE LOTTERY SYSTEM OUR MONEY TO BEGIN WITH? IN OTHER WORDS, ARE YOU TELLING ME, THAT AS A TAXPAYER I CAN NOT PAY-OFF THE SPORTS-WAGERING WINNINGS OF MYSELF OR OTHER TAXPAYERS FROM LOSSES BY MYSELF OR OTHER TAXPAYERS ON THE LOTTERY?

IN OTHER WORDS, YOU STEAL MONEY FROM THE TAXPAYERS AT 11,000,000 TO ONE ODDS, BUT NOT PAY THEM BACK AT 11 TO 10 (OR 15,000 FOR ONE - WHICH IS THE LARGEST OFFERED PARLAY CARD PAYOUT, AND THE SMALLEST BEING 05 FOR 01)?

IF YOU GAVE ME MONEY, MR. CHAIRMAN, I WOULD NOT PLAY IT ON THE LOTTERY AND WHICH SYSTEM HAS THE TAXPAYERS INTERESTS MORE AT HEART, YOURS AT 11,000,000 TO 01, OR MINE AT 11 TO 10? WHICH ONE LEAST CONSIDERS THE TAXPAYER AS THE "BANK OF LAST RESORT"? IF THAT STATEMENT WAS A VEILED REFERENCE TO MY "THE STATE AS THE HOUSE" PROGRAM, NOT ONLY DO I TAKE OFFENCE AS THE UNDERLYING PREMISE IS FALSE, YOU HAVE JUST COST THE STATE \$7.5-\$15.0 BILL.

INITALLLY, THERE IS THE "LOTTERY-IS-A-LOTTERY" STATEMENT. WITH RESPECT WHAT COULD THAT STATEMENT POSSIBLY MEAN? MY PROGRAM DOESN'T IMPACT THE LOTTERY IN THE LEAST; THEY WILL STILL SELL TICKETS. WOULD YOU HAVE TOLD THE WRIGHT BROTHERS, "HEY PUTTING WINGS ON A BICYCLE DOESN'T CONSTITUTE AN AIRPLANE, FELLAS ..."?

I HAVE GIVEN YOU A BRAND NEW AND INNOVATIVE SYSTEM. A SYSTEM THAT WILL MAKE THE SCHOOLS \$7.5 TO \$15.0 MILLION. A SYSTEM THAT IS CLEAN, FOOLPROOF, CAN NOT BE HACKED, IS EXTREMELY SWIFT AS TO THE EXCHANGE OF FUNDS, UTILIZES EXISTING EQUIPMENT, IS RELATIVELY LOW COST AND HIGH PROFIT, AND IS PATENTABLE AND EXPORTABLE TO ALL OTHER STATES WHO ARE MIS-MANAGING THEIR OWN PROGRAMS AND WOULD DESIRE TO INCREASE THEIR REVENUES 10-FOLD!

ALL THESE PUBLIC SECTOR DELAYS, NOT ONLY IN 1987, WHICH COST ME \$5.0 BILLION IN ROYALTIES, BUT IN THE CURRENT DAY HAS RESULTED IN THE THEFT OF THIS SYSTEM BY ONE OF MY COMPETITORS AT THE HANDS OF THE OHIO LOTTERY COMMISSION NO LESS. I CAN'T PROVE THIS, AS THE CHAIN OF EVIDENCE OCCURS IN SMOKE-FILLED ROOMS BEHIND CLOSED DOORS WHERE I AM NOT ALLOWED. I CAN ONLY TELL YOU WHAT I FEEL HAS HAPPENED BY THE OCCURRENCES THAT TAKE PLACE AND OTHER CIRCUMSTANCES AFTER THE CORRUPT COME OUT OF THESE ROOMS.

DOES ANYONE ELSE HAVE IT?!

IN OTHER WORDS, DOES ANYONE ELSE, OTHER THAN INTRALOT HAVE MY SYSTEM AND IS NOW PROPOSING IT IN THE SEVEN SAME OTHER STATES THAT I AM?! DOES MGM-GRAND?, DOES PENN-NATIONAL (WHO CALLED ME ABOUT IT AND STILL COULDN'T FIGURE IT OUT)?, DOES WYNN RESORTS?, DOES BOYD GAMING?, SHELDON ADELSON AND THE LAS VEGAS SANDS CORPORATION?, FANDUEL?, DRAFT KINGS?, ANYONE? ANY SINGLE LARGE GAMING COMPANY AND THEIR "EXPERTS". OTHER THAN INTRALOT THAT HAS AN ASSOCIATION WITH THE OHIO LOTTERY COMMISSION AND MY 118-PAGE PROPOSAL SUBMITTED TO THEM? PERHAPS THE INSPECTOR GENERAL NEEDS TO TURN HIS ATTENTION TO THIS AS WELL.

AND WHAT OF THIS PROPOSAL AND MY OTHERS? I FIRST CONTACTED ATTORNEY GENERAL DEWINE ON MAY 16TH, 2018 BY EMAIL, AS I KNEW HE WOULD BE GOVERNOR AND I KNEW THIS HAD GREAT POSSIBILITY FOR OUR STATE. HE SENT ME A "MR. LEVINE" BY PHONE WHO PROCEEDED TO TALK AT ME AND NOT WITH ME, DESIRING ONLY TO TELL ME WHY MY NEW PRODUCTS WERE NOT TECHNOLOGY. THIS RESULTED IN A \$15 BILLION LOSS TO OUR STATE. I WAS THEN UNDER THE TUTELEDGE OF A MR. MURRY, WHO WAS SIMPLY CHARGED WITH LEARNING AS MUCH ABOUT MY PLAN AS POSSIBLE. THIS DIDN'T HELP OUR \$15B IN LOSSES, EITHER.

I THEN SUBMITTED MY PROPOSAL TO THE OHIO LOTTERY COMMISSION AND A MS. NICOLE KOSTURA WHO WAS TO HAVE SCHEDULE MEETINGS BETWEEN THE DIRECTOR, UNTIL I REQUESTED "PROTECTED MYSELF AND THEN, DESPITE HER WRITTEN ASSURANCE THAT LOTTERY "WOULD NEVER STEAL ANYTHING I PRESENT", THEY SPIT BACK MY PROPOSAL WITHOUT SO MUCH OF A "HELLO, HOW ARE YOU", "THANKS SUBMISSION", A COVER LETTER, OR RECORDING SUBMISSION INTO THE COMMISSION'S MEETING MINUTES. EVIDENTLY. ALL THEY DID WAS HAND MY SYSTEM TO THEIR OPERATOR, INTRALOT, ON WHY, MR. CHAIRMAN, IS THIS NOT ACTIONABLE, AS SILVER PLATTER. DENAIL OF EQUAL OPPORTUNITY AND THEFT OF SERVICES BY THE OHIO LOTTERY COMMISSION AND WILL THIS COMMITTEE CONSIDER THIS AS I NOTICE ON PAGE 183 OF THE BILL THERE ARE WRITTEN PROVISIONS FOR PROTECTION OF TRADE SECRETS, PATENTS OR EXCLUSIVE LICENSES. (SEE EXHIBIT #05).

FROM THEIR PERSPECTIVE, ALL THE OLC DID WAS CREAT AT \$10 BILLION LOSS AS THE PROPOSAL WAS SUBMITTED TWO YEARS AGO. I ALSO SEE FROM A NEWS ARTICLE ABOUT SB-176 THAT EVEN IF APPROVED, WILL NOT ALLOW OPERATORS TO PROCEED UNTIL JANUARY OF 2022. THAT IS A WHOPPING 4-YEAR \$20 BILLION LOSS ON THE PART OF OUR GOVERNOR, OUR LEGISLATORS, AND YOUR COMMITTEE, MR. CHAIRMAN, THE VERY FOLKS WHO ARE CHARGED WITH MAKING A PROFIT FROM SUCH A VENTURE.

SUPPRESSION OF THE MARKET

THE ANTICIPATED "POOL" BET TO BE OFFERED BY THE OHIO LOTTERY AND THE RETAIL ESTABLISHMENT WILL NOT HELP THE RETAIL ESTABLISHMENT AS MUCH AS ETHER OF MY PLANS OR ANY OTHER "STANDARD" SPORTSBOOK OPERATION FOR THAT MATTER. IT WON'T INCREASE THE MARKET BASE; IN FACT, IT WILL SUPPRESS IT BY ITS STRUCTURE BY ATTRACTING ACTION TO A FEW EXTREMELY POPULAR GAMES LIKE THE BENGALS VS. THE BROWNS OR THE OHIO STATE GAMES. WHAT ABOUT LITTLE LOUISIANA LAFAYETTE, OR HARVARD/YALE FOR THAT MATTER?

THE MOCK-UP OF THE WEEK-03 PARLAY CARD, PROVIDED IN PREVIOUS TESTIMONY AND INCLUDED HEREIN AGAIN AS EXHIBIT #02 PROVIDES OVER 158 COLLEGE GAME OPTIONS FOR EITHER STRAIGHT BET OR PARLAY WAGERING. THE PRO-LINES AND SCHEDULES CAME OUT THIS WEEK, SO THERE ARE AN ADDITIONAL 32 OPTIONS ON THE SIDE AND OVER/UNDER. THIS WILL ALLOW WAGERS A LARGE RANGE OF OPTIONS, WHICH WILL MORE THAN LIKELY EXPAND THE NUMBER AND TYPE OF BETS MADE, NOT SUPPRESS IT AS POOL-WAGERING WILL. OUR CARD WILL BE THE ONLY ONE IN THE NATION, I'LL WAGER, OFFERING BETS ON ALL UPCOMING "FCS" TEAMS AS WELL AS THE BIG BOYS.

I ALSO ASKED ANDREA TO PROVIDE ME WITH AN ANSWER TO MY FIRST QUESTION IN MY MOSTRECENT 05-17-2021 EMAIL AND THAT IS: WHAT WILL HAPPEN TO THE POOL BET IF EVERYONE BETS ON THE BROWNS TO WIN AND NOT THE BENGALS? WILL THE WAGER BE CANCELLED, AS THE FINANCIAL EXPOSURE TO THE LOTTERY COULD BE AS HIGH AS \$18,000 OR AS LOW AS \$0.00 (USING YOUR ANALYST'S EXAMPLE OF A \$20,000 POOL BET). IN ADDITION, WILL THE \$2,000 JUICE ON THAT BET BE FORFEITED, CREATING ADDITIONAL NEGATIVE HANDLING AND MAILING COSTS OF RETURNING FUNDS? POOL BETS ARE A JOKE AND SHOULD BE RESERVED FOR POPULAR GAMES, IN "PICK-A-SQUARE" SCORE NUMBER CHARTS BY EACH QUARTER. THEN MAYBE THEY MIGHT MAKE MORE SENSE.

IN ADDITION TO THE POOL BETS, YOUR SYSTEM, ITSELF, SUPPRESSES THE MARKET BY LIMITING THE OUTLETS TO 40 PLAYERS. WOULD IT NOT BE BETTER TO TAKE WAGERS ACROSS THE STATE AT 10,000 TO 20,000 NEIGHBORHOOD LOTTERY TICKET DISPENSERS THAN SIMPLY 40 LOSS-MORE WAGERS, MORE RESULTANT FUNDS. LEADER FACILITIES? FRANKLY, I THINK UNDER MY CLASS 'C" COMPROMISE PROPOSAL, I BELIEVE WE CAN INCREASE THAT NUMBER TO 100,000 BY SIGNING EVERY RESTAURANT AND BAR IN THE STATE. IF THEY PUT THE WAGERING LINES OR OTHER ADVERTISING POINTING TO THEM ON OUR WEBSITE, ON THE RESTAURANT MENU'S OR PLACEMAYS, OR BAR COASTERS, YOU WILL SEE A BONANZA NO ONE EVERY CONTEMPLATED. WHAT DO PEOPLE DO EXCEPT BE BORED TO DEATH WHILE WAITING FOR THEIR MEALS? NOW THEY CAN BE AVIDLY DISCUSSING ALL THE GAMES AND WAGERS WITH EACH OTHER.

IF YOU SIGN 100,000 BARS AND RESTAURANTS THROUGHOUT THE STATE TO A CLASS "C" SPORTS-WAGERING LICENSE FOR \$1,000 EACH, THAT IS AN IMMEDIATE \$100,000,000 WINDFALL FOR THE STATE (LESS MY 10% FOR INVENTING IT).

MY COMPROMIZE PROPOSAL

WHAT THEN IS MY COMPROMISE PROPOSAL? IT DIVIDES THE MARKETS FOR THE TWO MAIN BENEFICIARIES, THE STATE AND SCHOOLS SYSTEM VS. THE CASINO INDUSTRY IN-HALF AT THE PARLAY CARD. THE STATE BY WAY OF THE OLC UNDER MY SUPERVISION AS ADMINISTRATOR (YOU HAVE TO HIRE SOMEONE TO RUN IT, IT MIGHT AS WELL BE THE INVENTOR, EH?) WILL RUN THE PARLAY CARDS BY WAY OF ITS LOTTERY TICKET DISPENSERS. AND THE CASINO INDUSTRY SHALL BE RESPONSIBLE FOR ALL OTHER TYPE OF BETS, SINGLE STRAIGHT BETS, OVER UNDERS, TEAZERS, FUTURES, IN-GAME, EXCHANGE, LAY-OFFS, AND YOUR FAVORITE, MR. CHAIRMAN, PROPOSITION BETS. THE OCCC SHALL BE THE OVERSEER OF THIS HALF OF THE OPERATIONS.

THIS WILL BENEFIT THE SCHOOLS AND THE NEIGHBORHOODS BY AN ESTIMATED \$375 MILLION PER YEAR AND OFFER AN INFINITE AMOUNT OF FLEXIBILITY FOR BETTERS. AND AS YOU CAN SEE FROM MY SECTION ON CONSTITUTONALITY BELOW, YOU NEED TO TAKE A VERY SERIOUS LOOK AT THIS, AS THERE ARE CONSTITUTIONAL PROVISIONS THAT WILL ALLOW ALL THE RETAILERS TO TELL THE STATE TO "GO POUND SAND" AND GO OFF ON THEIR OWN AND THERE WON'T BE A SINGLE THING THE STATE CAN LEGALLY DO ABOUT IT..

THEN YOU WILL REALLY HAVE THE "WILD WEST" SCENARIO THAT VICE CHAIRMAN MANNING REFERRED TO IN HIS 5-12-2021 PRESENTATION.

IF YOU WANT TO TAKE THE AIR OUT OF THAT BALLOON, THE CLASS "C" COMROMISE PLAN IS THE ANSWER. IT PUTS ALL THE LITTLE GUYS INTO THE SAME SINGLE SOURCE FOR TAKING, GRADING AND PAYING-OUT ALL TICKETS, WHICH NOT ONLY INCREASES ACCURACY AND CREDIBILITY STATE-WIDE, IT WILL ELIMINATE THE INCENTIVE FOR THE RETAILERS TO SUE FOR THEIR RIGHTS UNDER THE CONSTITUTIONAL PROVISIONS BELOW OR GO OUR ON THEIR OWN, AS THEY HAVE NOW BEEN INVITED TO THE PARTY.

ADDITIONAL PRODUCTS

AS I SAID IN MY FIRST ORAL PRESENTATION, I HAVE CREATED THREE ADDITIONAL NEW PRODUCTS THAT WILL RAISE BILLIONS FOR THE STATE BEYOND ITS BORDERS. THOSE PRODUCTS ARE:

- 01.A NEW SPORTS-WAGER FOR WOMEN
- 02.A NEW CASH COLLECTION SYSTEM FOR STATE LOTTERIES
- 03. THE BANK-DROP SYSTEM

WHILE THIS NEW "GEO-NETTING" SOFTWARE WILL PREVENT US FROM TAKING WAGERS IN OTHER STATES, THERE IS ABSOLUTELY NOTHING TO KEEP US FROM LICENSING THESE NEW PRODUCTS TO THE STATES AND THEIR OPERATORS FOR A FEE, BRINGING IN ADDITIONAL FUNDS FROM BEYOND STATE BORDERS.

I HAVE GIVEN YOU A PRO-FORMA (SEE EXHIBIT #03) ENCOMPASSING 01 OF THE 09 SEGMENTS OF THE MARKET WHICH RESULTED IN AN EXTRA \$142 MILLION FOR THE STATE. DO YOU WANT THESE EXTRA FUNDS, OR NOT, AS I HAVE YET TO HEAR FROM ANYONE ON THIS, THE GOVERNOR, THE OLC OR OCCC, OR THIS COMMITTEE. CAN YOU NOT STAND PROPSERITY OR IS THE SUBTITLE OF SB-176 "RICK OHANIAN AND HIS PROGRAMS AND INVENTIONS SHALL NOT BE PART OF THIS BILL."

IF THAT IS NOT THE CASE, I WOULD ADD AN AMENDMENT ENTITLED "INNOVATION" THAT SAYS ANY PARTY WHO COMES TO THE OLC OR OCC WITH AN INNOVATIVE NEW PRODUCT SHALL SHARE THE PRODUCT ON A 50/50 BASIS WITH ONE OF THEM IN EXCHANGE FOR THE STATE OF OHIO PAYING FOR THE PATENT AND TRADEMARK LEGAL WORK; AND THAT IS MY EXACT PROPOSAL TO THE STATE OF OHIO.

PLEASE NOTE ALSO ON PAGE TWO OF EXHIBIT #03 THAT THIS PRO-FORMA ONLY COVERS 01 OF THE 09 POTENTIAL SEGMENTS OF THE MARKET. COVERING THE OTHER NINE, MIGHT VERY WELL MAKE THIS PRODUCT AND THE RESULTANT LICENSING FEES WORTH WELL OVER A BILLION DOLLARS.

CLASS "D" SPORTS-WAGERING LICENSE

YOU MAY WISH TO CREATE THIS PRODUCT ALSO, ANOTHER INVENTION OF MINE (IN EXCHANGE FOR 10% TO ME AS THE INVENTOR), AS MY PROPOSALS INVOLVE THE COLLEGE AND UNIVERSITYS OF AMERICA, BIG TIME, PERHAPS REDUCING OR TOTALLY ELIMINATING THEIR COVID-RELATED ATHLETICS DEPARTMENT BUDGETS FOREVER. (AND I THINK THIS IS IMPORTANT BECAUSE I DON'T THINK THIS THING IS GOING AWAY SOON DUE TO GLOBAL MISMANAGEMENT BY UNDERDEVELOPED COUNTRYS AND OUR STUPID OPEN-BORDER POLICIES (AND CATCH AND RELEASE AS WELL).

A CLASS "D" SPORTS-WAGERING LICENSE SHALL BE GRANTED TO ANY COLLEGE OR UNIVERSITY WITH A FOOTBALL AND/OR BASKETBALL PROGRAM SUCH AS OHIO STATE, CINCINNATI, ALL THE MAC SCHOOLS, DAYTON, CLEVELAND STATE AND WRIGHT STATE, FOR THE INITIAL FEE OF \$1.00 PER SEAT AND 10% OF GROSS PRODUCTION, EACH YEAR THEREAFTER.

OVERSEAS MARKET

UNLESS THIS GEO-NETTING PRINCIPAL IS WORLD-WIDE (WHICH IT SHOULDN'T BE) AS WELL AS STATE-WIDE, I SEE NO IMPEDIMENT TO THE STATE OF OHIO OPERATING ITS WEBSITE - ESPECIALLY WITH MY THREE NEW PRODUCTS, IF PATENTED - INTERNATIONALLY.

THE OFF-SHORES (CREATED BY PASPA-92 AND THE PAROCHIAL ATTITUDES OF THE NCAA AND NFL HHTO BEGIN WITH) HAVING BEEN RIPPING OFF AMERICA FOR BILLIONS IN THE PAST 29 YEARS, IT'S ABOUT TIME WE RETURN THE FAVOR, AND MY PROPOSALS TO THE STATE WILL DO EXACTLY THAT, AGAIN, CREATING ADDITIONAL FUNDS FROM BEYOND OUR BORDERS.

AS TO THIS GEO-NETTING COMCEPT, ENCLOSED AS EXHIBIT #06 IS AN ILLEGAL ADVETISEMENT THAT I HAVE ALEADY RECEIVED FROM MGM AND MANY OTHERS. PER SB-176 REGARDING VIOLATING THE OPERATOER'S TERMS OF THE LEGISLATION WOULD THIS NOT DISQUALIFY THEM FOR PARTICIPATION IN OHIO?

VIOLATION OF CONSTITUTIONALITY

SB-176 AT PRESENT AND AS WRITTEN VIOLATES AT LEAST SIX CLAUSES IN THE CONSTITUTION AS FAR AS I CAN TELL. PERHAPS IN THEIR DUTIES AND MISSION STATEMENTS, ATTORNEY GENERAL DAVE YOST, AND THE OHIO SUPREME COURT CAN TAKE A LONG AND FORMAL LOOK AT THIS BEFORE THIS UNFORTUNATE BILL PASSES. IT VIOLATES THESE CLAUSES BY ATTEMPTING TO LIMIT WHO CAN AND CANNOT BE "THE HOUSE". CHAIRMAN SCHURING CALLS THE "FREE MARKET" SYSTEM; I VEHEMMENTLY DISAGREE AND CALL IT THE "RUSSIAN OLIGARCH-40" PLAN AS FOLLOWS.

TO BEGIN WITH THE WOMEN'S MOVEMENT AND THE CIVIL RIGHTS LONG SINCE PROVEN YOU CAN NOT MOVEMENET HAVE LIMIT WHO MAY PARTICIPATE IN A LEGAL AMERICAN BUSINESS. IT'S LIKE SAYING ONLY RICH PEOPLE CAN BE THE HOUSE AND POOR PEOPLE CAN NOT, POOR PEOPLE CAN ONLY BE THE PLAYERS. AND ALL OF THIS IS ROOTED IN LAW, PURSUANT TO THE 14TH AMENDMENT AS FOLLOWS.

All persons born or naturalized in the United States and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. No State shall **make** or **enforce** any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.

NOTICE FIRST THE WORD "MAKE". CAN TRY, BUT THEY WOULD BE FACING CIVIL ACTION FOR FALSE ARREST INTERFERENCE WITH A LEGAL AMERICAN BUSINESS. TORTUOUS PRAYTELL HOW ARE WE ALL GRANTED EQUAL PROTECTION UNDER THE LAW WHEN IT IS THE VERY LAWS THAT ARE DENYING IT?

JUXTAPOSED AGAINST THE SUPREMACY CLAUSE, ARTTICLE VI, PARAGRAPHS 02 AND 03 OF THE U.S. CONSTITUTION, WHICH STATE THAT THEREBY" JUDGE SHALL BE BOUND ALLAN "UNAPPROVED" OPERATOR HAS TO DO IS WAVE THE 14TH AMENDMENT AND THE SUPREMACY CLAUSES IN FRONT OF THE JUDGE AND STATE, "IF YOU RESPECT THE CONSTITUTION AND ARE BOUND THEREBY, YOUR HONOR" PLEASE GO? WHAT DOES THIS MEAN EXCEPT **VIOLATES** CONSTITUTION THAT SB-176 THE AND SO DO ADDITION LEGISLATORS WHO CRAFTED IT. SO IN TO VIOLENTLY SHIRKING THEIR RESPONSIBILITIES TO THEIR CONSTITUENTS, FIDUCIARY DUTY TO THE TAXPAYERS AND THE SCHOOL SYSTEM, THEY ARE VIOLATING THE UNITED STATES CONSTITUTION AS WELL. MAYBE IT IS TIME TO GET THE FBI INVOLVED AS TO THESE POTENTIAL CRIMES AS WELL AS THE ATTORNEY GENERAL, THE INSPECTOR GENERAL AND THE OHIO SUPREME COURT.

THE SUPREME COURT - UNDER THE ANTI-COMMANDEEREING NOTIONS IN THE CONSTITUTION - LIMITED THEIR DETERMINATION TO THE FACT THAT THE FEDERAL GOVERNMENT "COULD NOT TELL THE STATES WHAT TO DO." THE APPROVAL AND DISPPROVAL OR WHO CAN AND WHO CANNOT CONDUCT SPORTS-WAGERING IS THEN THE PROVINCE OF THE 10T AMENDMENT, THE STATES OR THE PEOPLE.

UNDER THAT NOTION OF THE STATES AND THE PEOPLE BEING EQUAL ENTITIES, I FAIL TO SEE WHY THE STATE FEELS IT HAS DOMINION OVER US ON THIS ISSUE, ESPECIALLY WHEN THEY ARE COMMANDEERING (THERE'S THAT WORD AGAIN) GOODS AND SERVICES THEY DON'T EVEN OWN NOR DID THEY PRODUCE! IF THE TRUTH BE TOLD, IT IS THE NFL, NCAA AND OTHER SPORTS LEAGUES THAT ARE THE TRUE OWNERS OF THE PRODUCT, BUT HEADS OF THEIR ORGANIZATION ARE TOO STUPID TO RECOGNIZE THIS NATURALLY OCCURING MONOPOLY ON THEIR OWN, NOR DID THEY WHEN I PRESENTED IT TO THEM THREE YEARS AGO.

AFTER EVERY NFL OR NCAA TELECAST YOU HEAR SOMETHING TO THE EFFECT THAT: "THIS TELECAST IS COPYRIGHT 2021 BY THE NFL (OR NCAA) AND MAY NOT BE REPRODUCED OR UTILIZED IN ANY MANNER WITHOUT THE EXPRESSED WRITTEN CONSENT OF THE NFL (OR NCAA)."

WELL THEY COULD HAVE AND SHOULD HAVE MADE A SIMILAR ANNUNCEMENT ABOUT THE FINAL OUTCOME OF THE GAME. DID YOU EVER TRY TO GRADE A WAGER EITHER AGAINST THE SPREAD, MONEY LINE, OVER/UNDERS AND ALL ELSE WITHOUT KNOWING FIRST, WHO WON THE GAME (FOR MONEYLINERS) AND SECOND BY WHAT RELATIVE AMOUNT (FOR THE REST).

ALL THEY HAD TO DO WAS MAKE A SIMILAR ANNOUNCEMENT FOR THE FINAL OUTCOME AND THE LAST LINE OF THE 5^{TH} AMENDMENT WOULD HAVE BEEN THEIR LEGAL PROTECTION AND UNION BOOK AS FOLLOWS:

; nor shall private property be taken for public use, without just compensation.

CAN IT BE ANY MORE CLEAR THAN THAT? THOSE GAMES ARE PRIVATE PROPERTY, PROTECTED BY THE CONSITUTION, PRODUCED LITERALY BY THE BLOOD, SWEAT AND TEARS OF THE PLAYERS, THE COACHES, THE ASSISTANT COACHES, THE REFEREES, MANAGEMENT AND THE OWNER, THE NETWORKS AND TO A CERTAIN EXTENT THE FANS - NOT THE STATES. AND THE STATES AND THESE CASINO CARPETBAGGERS ARE BENEFITING WHOLLY DISPROPORTIONATELY COMPARED TO THE SPORTS TEAMS AND THE PUBLIC.

NOW, HILARIOUSLY, THE SPORTS TEAMS ARE RUNNING AROUND THE ENTIRE COUNTY, LIKE CHICKEN WITH THEIR HEADS CUT-OFF, STATE-TO-STATE, CHASING THEIR TALES AND THIS ONE PERCENT, (01%), INTEGRITY FEE - THAT NO ONE SEEMS TO BE WILLING TO GRANT THEM - WHEN THE ENTIRE GOLDMINE WAS THEIRS FOR THE TAKING FROM THE GET-GO. AS I RELATED IN ONE OF MY VIDEOS, AT PRESENT YOU HAVE TO WIN 53% OF YOUR BETS JUST TO BREAK-EVEN. ADDING WITHHOLDING OF 10% NOW KICKS THAT UP TO 64%, JUST TO BREAK EVEN. NO ONE ON EARTH, EVEN THE "WISE-GUYS", CAN WIN BETS AT THAT PACE.

SO WHAT THIS WILL DO IS DRIVE PEOPLE BACK TO THE OFFSHORE MARKET, WHERE SOME OPERATORS EVEN LOWER THE JUICE FROM 10% TO 05%, APPROACHING A 50/50 CHANCE AT WINNING. SO IF YOU WANT TO ATTRACT PLAYERS, AND MOREOVER, KEEP PLAYERS PLAYING ALL YEAR LONG, I WOULD SUGGEST AT LEAST DOING AWAY WITH ANY WITHHOLDING ON SINGLE BETS.

EMERGENCY PROPOSAL

THE LAST NEWS ARTICLE I READ ABOUT THE PROGRAM STATED THAT EVEN THOUGH THE LEGISLATION MIGHT BE APPROVED BY JUNE, THAT NO OPERATOR WOULD BE ALLOWED TO COMMENCE BEFOR JANUARY 01, 2022.

IT DON'T UNDERSTAND THE WISDOM OF THIS, AS IT MEANS MISSING (FOR THE FOURTH YEAR IN A ROW) THE UPCOMING COLLEGE AND PROFESSIONAL FOOTBALL SEASONS, WHICH - AS YOU CAN SEE FROM THE MONTHLY TOTALS IN EXHIBIT #01 - IS WHEN THE LION'S SHARE OF SPORTS-WAGERING TAKES PLACE.

AS A RESULT MY TESTIMONY FOR THE 5-19-2021 HEARING INCLUDES AN EMERGENCY PROPOSAL WHICH IF THE GOVERNOR SIMPLY SIGNS IT, WILL ALLOW US TO MALE BILLIONS FROM THIS YEAR'S SEASONS INSTEAD OF LOSING THEM AS WE HAVE IN THE PAST. NOT ENACTING THIS PROPOSAL WILL CONSTITUTE A GROSS \$20 BILLION LOSS OVER THE LAST FOUR YEARS OF SQUABBLING AND INEPTITUDE.

SPORTS TEAMS RELEGATED TO CLASS "C" LICENSES

IN MY WRITTEN TESTIMONY SUBMITTED LAST WEEK, I GAVE A NUMBER OF EXAMPLES OF HOW GAMES COULD BE FIXED, INCLUDING BY OWNERS OR MANAGEMENT. I AM NOT SAYING ANY OF OUR OWNERS WOULD TO THIS, I AM JUST SAYING GRANTING THEM A CLASS "A" OR "B" LICENSE OPENS THE DOOR FOR THIS TO HAPPEN. WHY CHANCE IT?

IN CONCLUSION:

APPOINT ME IN EXCHANGE FOR 10% OF NET, AS OVERSEER OF THESES TWO PROGRAMS. THIS CAN BE DONE WITHOUT COMPETITIVE BIDDING FOR THE REASONS THAT I TOLD YOU: THAT I INVENTED THE SYSTEM; 2.) KNOW MORE ABOUT HOW IT IS SUPPOSED TO OPERATE THAN ANY MAN ALIVE; AND 3.) POSSESS THREE NEW PRODUCTS THAT NO OTHER CASINO COMPANY HAS INCLUDING INTRALOT!
- 03.ENTER INTO IMMEDIATE NEGOTATIONS FOR MY TWO PATENTABLE PRODUCTS THAT WOULD RAISE ADDITIONAL REVENUE FOR THE STATE BEYOND ITS BORDERS ON A 51/49 BASIS, 49% OF ALL REVENUE TO THE STATE FOR PAYMENT OF ALL LEGAL SERVICES ASSOCIATED WITH THE PATENT AND TRADEMARK WORK, BY WAY OF A STATE TECHNOLOGY GRANT, SO WE DON'T WASTE ANY MORE PRECIOUS TIME AND HAVE ONE OF MY COMPETITORS DISCOVER ONE MORE OR ALL OF THESE NEW PRODUCTS. THIS WILL COST THE STATE BILLIONS AS WELL AS MYSELF.

AS TO THE SPORTS-WAGERING LEGISLATION, AS I HAVE ALWAYS SAID, "WHY SELL THE COW, WHEN YOU ARE GETTING THE MILK FOR FREE?" AND IN THIS CASE MISS ELSIE IS WORTH \$7.5- \$15.0 BILLION TO THE STATE AND ITS TAXPAYERS. (SEE EXHIBIT #04).
