Maurice "Mo" McDonald is a Director at PESystems, Inc. PESystems provides reliable technology services to federal agencies and commercial enterprises. In his capacity, Mo is responsible for managing a contract valued at over \$418 million and 420 personnel providing program management, engineering, cyber security, logistics, test and evaluation and administrative support to the Air Force across 5 locations nationwide.
