Ward J. "Tim" Timken, Jr. is the Chief Executive Officer of McKinley Strategies. In his role, he is the managing partner of the general business-consulting portion of the firm and oversees and works across other functions of the business such as government affairs, political, and grassroots.

Prior to co-founding McKinley Strategies, Tim was the chairman, CEO, and president of TimkenSteel Corporation (TMST). Prior to his time with TimkenSteel, Tim served as executive Chairman and CEO of The Timken Company (TKR), a Fortune 500 company at the time, leading a strategy that resulted in more than tripling the stock price during his tenure.

He joined The Timken Company's steel business in 1992 and progressed through a series of roles in sales and marketing management and geographic leadership in Europe and Latin America, where he helped fuel the company's global growth.

Tim is a member of the Board of Directors at The Timken Company, a member of the board of Team NEO (past chairman), the Stark Economic Development Board, and the Timken Foundation. Tim has previously served on the board of the American Iron and Steel Association (past chairman), Pella Corporation, National Association of Manufacturers executive committee, the Ohio Business Development Council, The Ohio Business Roundtable executive committee among other philanthropic and community organizations.

He holds a bachelor's degree from Georgetown University and a Master of Business Administration degree from University of Virginia's Darden School of Business. After his time at the Darden School, Tim opened and managed a Washington D.C. lobbying firm for Ohio based lobbying firm McGough and Associates.
