(D) An attorney who is licensed to practice law in this 30  
state, on behalf of the corporation, association, or other 31

evidentiary support for the issuance of a temporary protection 33  
order pursuant to section 2903.213 of the Revised Code or a 34  
protection order pursuant to section 2903.214 of the Revised 35

(E) Any temporary protection order issued pursuant to 37  
section 2903.213 of the Revised Code or any protection order 38  
issued pursuant to section 2903.214 of the Revised Code shall 39  
specify with particularity the location or persons to be 40  
protected by the temporary protection order or the protection 41
