"**Sec. 3302.063.** (A) Except as provided in division (B) of 4
this section, upon designation of a school district of innovation 5
under section 3302.062 of the Revised Code, the state board of 6
education shall waive any laws in Title XXXIII of the Revised Code 7
or rules adopted by the state board that are specified in the 8
innovation plan submitted by the district board of education as 9
needing to be waived to implement the plan. The waiver shall apply 10
only to the school or schools participating in the innovation plan 11
and shall not apply to the district as a whole, unless each of the 12
district's schools is a participating school. The waiver shall 13
cease to apply to a school if the school's designation as an 14
innovation school is revoked or the innovation school zone in 15
which the school participates has its designation revoked under 16
section 3302.065 of the Revised Code, or if the school is removed 17
from an innovation school zone under that section or section 18
3302.064 of the Revised Code. 19
