Defines "cargo theft," and adds cargo theft as a type of organized retail theft activity that the organized retail theft task force investigates. 33

Prohibits a person from knowingly committing theft of	39
retail property with a retail value of \$1,000 or more from a	40

\$1,000 or more from a retail manufacturer or distributor, or	44
cargo transportation unit as part of an organized plan to commit	45

Allows a retail manufacturer, distributor, cargo	47
transportation unit, online marketplace, or group of those	48
entities to contact the prosecuting attorney, if a pattern of	49
