Allows a money transmitter that timely files the required 61 quarterly report and pays the aggregate amount of the transfer 62 fees to the superintendent of financial institutions to reduce 63 the transmitter's fee liability by 0.75%, similar to the sales 64 tax prompt-payment discount authorized under continuing law. 65

Limits the use of grant funds to investigate human 66 trafficking and drug trafficking and enforce related laws. 67

Requires the Director of Public Safety, in administering68the grant program, to ensure the funds are distributed equitably69(1) among law enforcement agencies of varying sizes and (2)70jurisdictions and geographically throughout the state.71
