Chair Abrams, Vice Chair Williams, Ranking Member Brown and members of the House Criminal Justice Committee:

I am writing to express my strong support for this committee to support House Bill 161 and to eliminate the Spousal Rape Exception from the Ohio Revised Code. As the CEO of the Battered Women's Shelter and Rape Crisis Center of Medina & Summit Counties, I have witnessed the harrowing and enduring impact of spousal rape on survivors and their families. It is imperative that we take decisive action to rectify this injustice.

Spousal rape is a deeply distressing and pervasive issue that continues to undermine the safety, dignity, and well-being of countless individuals within our society. Despite significant progress in recognizing and addressing sexual violence, it is unconscionable that the legal system still lags behind when it comes to acknowledging and prosecuting rape within the confines of marriage.

Our organization provides a lifeline to survivors of sexual assault and domestic violence, offering them a safe space to heal, receive support, and access essential resources. We have been confronted with the tragic reality that many survivors of spousal rape are left without the legal recourse and protection that victims of non-spousal rape receive. The legislation before you represent a critical step towards ensuring that all survivors of sexual assault, regardless of their relationship with the perpetrator, receive equal protection under the law. By closing the spousal rape loophole, we can send a powerful message that consent is a fundamental human right, and any violation of it will not be tolerated or excused.

Moreover, closing this loophole will not only provide survivors with the legal recourse they deserve but also serve as a deterrent against spousal rape. It will emphasize that marital status should never be a shield for perpetrators of sexual violence and that accountability will be enforced.
