Testimony on HB 33

Presented by Dr. Lisa Hinkelman, Founder and CEO of Ruling Our eXperiences (ROX)

April 20, 2023

Chair Edwards, Ranking Member Sweeney, Vice Chairman LaRa and all members of the House Finance, thank you for the opportunity to speak today regarding the FY 2024-2025 operating budget for Ruling Our eXperiences (ROX), the leading nonprofit organization focused on programming, research and education centered on girls.

My name is Dr. Lisa Hinkelman, I am a counselor, educator, researcher, speaker and author who has spent nearly twenty years working in schools, conducting research with girls and educating girls and adults first as a professor at The Ohio State University, and for the last 12 years, as the Founder and CEO of ROX.

The world is complicated for girls. Confidence. Stress. Pressure. Social Media. Body Image. When I started my work and research in this area, I never could have imagined that today we would be reporting that girls' confidence drops 26% between 5th and 9th grade and that it doesn't recover; that one in three girls say that they are afraid to be a leader because others will think that she is bossy and that half of girls report that they are afraid to speak their mind or disagree with others because they want to be liked.

Couple this with the findings from the February 2023 CDC report from the Youth Risk Behavior Survey which revealed that nearly 60% of high school girls reported feeling persistently sad or hopeless, 30% have seriously considered suicide and 1 in 5 experienced sexual violence within the past year. **It is clear that all girls need connection, support, and skills and that is precisely what we are doing at ROX.**

At ROX we train and license school counselors, social workers, and educators to deliver a 20-week in depth, evidence-based curriculum to girls in grades 5-12. ROX sessions focus on team building, effective communication, girl drama and bullying, healthy relationships and support networks, social media, body image, sexual harassment, safety and violence prevention, stress and coping, academic and career development, and leadership. Meeting once a week for twenty weeks as a part of the school day, ROX equips girls with the skills they need to navigate the challenges that they face, and supports each girl in actualizing her full potential.

And the data tells us that ROX works. Pre- and post-tests with more than 30,000 participants since 2006, show that girls in ROX report higher levels of confidence, more supportive and less competitive relationships with other girls, and an increased connection to school. ROX girls are more adept at standing up for themselves and are more likely than their peers to believe that their voice and opinion matter. An independent data analysis of ROX outcomes showed that 84% of girls made new friends in ROX, 89% can respond to bullying more effectively, and more than 95% can identify strategies to keep them safe online *and* in potentially threatening situations. Perhaps most importantly at this particular moment, is that 94% of girls say that ROX is a place at school where they feel included.

Parents and school administrators concur with these findings. When surveyed, 96% of parents reported observing their daughter use the skills that she learned in ROX. Ninety-three percent said that having ROX helped their daughter manage bullying/drama more effectively and 98% said they would like their school to continue to provide the ROX program.

When school staff and administrators were surveyed about the impact of ROX, 70% reported a reduction in girl bullying/drama, 86% observed girls demonstrating more leadership skills and 85% saw an improvement in overall school climate.

The Ask: Reestablish funding support in the budget for ROX through a GRF designation.

ROX is a nonprofit organization that operates a school-based program centered on equipping girls with the information and skills that they need to live healthy, safe, productive and violence-free lives. ROX operates in **321 schools throughout Ohio** and currently impacts nearly **5,000 girls in the state, across 44 counties**.

ROX trains and licenses professional school counselors, social workers and educators to deliver a **20-week evidence-based program** in schools for girls that helps girls develop the skills to navigate the challenges they face during middle and high school. Starting in 5th grade, ROX programs are delivered in schools, during the school day, and are available to girls up through grade 12.

In ROX, girls learn how to **communicate** effectively, develop **healthy relationships**, support other girls, form a **healthy body image**, navigate **social media**, manage **stress** and pressure, **stay safe** and **defend themselves** and plan for **college** and their **career**.

ROX FUNDING

It costs \$650 to train a new ROX facilitator via a 22-hour professional development experience. Once trained, facilitators run ROX programs in their schools and are supported by ROX with everything they need to implement their program including: pre- and post-data collection and reporting; materials, supplies and swag for ROX girls; parent resources including a book, newsletters and webinar access; on-demand coaching and professional development. The cost of this implementation is \$150/girl.

ROX does not charge individual girls or families for program fees, rather utilizes a combination of philanthropy and school support to implement ROX programs. Through this shared-cost model ROX raises \$50 of every \$150 participant fee in order to make the program as accessible for schools as possible.

PREVIOUS SUPPORT FOR ROX

ROX received \$232,850 in the 2019-2020 biennial budget, resulting in direct impact for thousands of girls across Ohio at a time where they needed it most. In 2019-2020 ROX served 6,860 Ohio girls despite the challenges that the COVID-19 pandemic brought to our schools and communities.

Students did not experience a gap in services from ROX, instead, the support dollars allowed ROX to pivot quickly to engage instructional designers to transform our in-person program delivery model to an online delivery model. The Virtual ROX and e-learning content has been used in remote, hybrid and in-person learning environments with more than 2,800 ROX girls.

In addition, ROX responded to the pandemic by increasing our program evaluation and impact reporting; delivering parent webinars and providing materials and resources for parents of program participants; providing professional development and materials for school staff; developing an online resource and support portal for program facilitators.

2. Vendor forms – required if you wish to change your registration in the State’s accounting system

3. FY20 Year-End Earmark Evaluation Document (not included with this letter)

You are required to complete submit the FY20 Earmark Recipient Pre-Planning Document. This information should be submitted to Aaron Rausch at Aaron.Rausch@education.ohio.gov. Vendor forms should be completed directly on the Ohio Shared Services website.

Upon receipt of these documents, the first payment of 25% of the total earmark will be issued. Subsequent payments of 25% will be issued quarterly in October, January, and April.

At the end of the fiscal year, you will receive the FY20 Year-End Earmark Evaluation Document. This document will need to be submitted to ODE in July, 2020.

Upon receipt of these documents, the first payment of 25% of the total earmark will be issued. Subsequent payments of 25% will be issued quarterly in October, January, and April. ***The coronavirus pandemic has, and will continue to have, a negative impact on the state's financial position. The state's plan to manage revenue shortfalls and ensure a balanced budget in FY21 continues to be developed. As a result, quarterly payments will be reduced by 3.72%.***

At the end of the fiscal year, you will receive the FY21 Year-End Earmark Evaluation Document. This document will need to be submitted to ODE in July, 2021.
