Chair Peterson, Vice-Chair Thomas, Ranking Member Humphrey, and members of the Government Oversight Committee, thank you for the opportunity to provide sponsor testimony on House Bill 475.

HB 475 aims to safeguard taxpayer dollars by preventing municipalities, counties, and other local authorities from using public funds to support elective abortions or abortion services. Prior to the passage of Issue 1 in November, we witnessed instances where cities like Toledo, Cleveland, and Cuyahoga County allocated substantial sums for out-of-state travel related to abortions. ¹²³ Now, with Issue 1 in effect, these cities have alternative avenues for funding elective abortion services. Recognizing the diversity of opinions among voters, HB 475 ensures that taxpayers are not compelled to finance services they fundamentally oppose.

Transparency is the bedrock of effective governance. Citizens have a right to know how their hardearned money is allocated. I firmly believe in responsible use of public funds. HB 475 establishes a robust mechanism for tracking and controlling state allocations to local governments. By withholding funds from entities directly supporting elective abortions, we uphold fiscal responsibility and accountability. Public safety, education, and infrastructure should never be compromised in favor of facilitating abortions. HB 475 prevents the State of Ohio from subsidizing local governments that utilize tax dollars for elective abortion services.

Specifically, the bill deducts from Local Government Funds (LGF) distributed to counties and municipalities at a 1:1 ratio for public funds used in elective abortion-related activities.
