Written Testimony in Support of HB 455

Dear Members,

As the (first) Honorary Consul of Ireland in Ohio, I am honored to express my wholehearted support for HB 455, to enact section 149.60 of the Revised Code to establishment the Ohio Ireland Trade Commission. This initiative stands as a landmark proposal to enhance our robust economic relationships and to foster increased collaboration, innovation, and mutual prosperity between Ohio and Ireland.

The Irish have made significant contributions to a variety of industries, which have helped to shape the Ohio economy. Irish immigrants played a significant role in the iron and steel industries in towns like Cleveland and Youngstown, laboring in factories and mills that were essential to the state's economic growth. Many Irish immigrants worked in the coal mining areas of southeast Ohio, contributing to the expansion of the state's energy industry. Irish business owners founded everything from restaurants and bars to construction firms in cities like Cincinnati, boosting the local economy and offering vital services to their communities.

The labor provided by Irish immigrants, often in challenging and demanding conditions, played a significant role in the growth of Ohio's transportation infrastructure, including canals, railroads, and later, highways. During his tenure, Gavin—who was born in Ireland—played a significant role in extending and modernizing Cleveland's infrastructure. He supported efforts for economic development, assisted in the creation of public parks, and pushed for upgrades to the city's water supply.

Co-founder of Procter & Gamble James Gamble is another notable Irish immigrant who made a lasting impression on Ohio. Gamble, who was born in Ireland, emigrated to the US and settled in Cincinnati. In 1837, Gamble and his brother-in-law, William Procter, co-founded Procter & Gamble, which was initially a soap and candle manufacturing company. Procter & Gamble grew its product ranges and rose to prominence as one of the biggest consumer goods corporations in the world under Gamble's direction. Beyond his financial skills, James Gamble left behind a legacy of civic involvement and generosity. His contributions to Cincinnati's education and healthcare systems, among other humanitarian causes, had a long-lasting effect on the city and its citizens.

These people, along with many others, have had a profound impact on Ohio's history and development, highlighting the important contributions Irish immigrants have made to the political, economic, and social fabric of the state.

In this era of increasing connectivity, the establishment of the Ohio Ireland Trade Commission could not come at a better moment. This commission is a proactive move that will help to leverage the current strong flows of investment and trade between our two areas. Ireland, with its strategic location in

Europe and dedication to technological innovation, and Ohio, with its varied economy and robust industrial base, make for ideal partners. Through the Ohio Ireland Trade Commission, we can formally establish this partnership and open new prospects in biotechnology, technology, agriculture, and education.

Furthermore, the establishment of the Ohio Ireland Trade Commission will foster significant opportunities for our institutes of education.
