Representative Young motioned to amend Sub SB 40 with AM\_135\_2099.  
The amendment was accepted without objection.  
Ranking Member Somani motioned to amend AM\_135\_1833 with AM\_135\_2109  
Vice Chairwoman Gross moved to table AM\_135\_2109.  
Roll was taken. With 8 yays and 5 nays, the amendment was tabled.  
Chairman Cutrona recognized Dr. Mark Armstrong, Rick Lantz, and Erika Cybulskis for opponent testimony. No questions were asked by the committee.  
Vice Chairwoman Gross moved to favorably report Sub SB 40. Roll was taken. With 9 yays and 4 nays, Sub SB 40 was reported out of committee.

Chairman Cutrona called Sub SB 28 for its 3rd hearing.  
Vice Chairwoman Gross motioned to amend Sub SB 28 with AM\_135\_2094.  
The amendment was accepted without objection.  
Vice Chairwoman Gross motioned to amend Sub SB 28 with AM\_135\_1094-3.  
The amendment was accepted without objection.  
No witnesses were present.
