RE: OPPOSITION TO HOUSE BILL 6

Dear Representatives,

I am the father of three adulet children and grandfather to 4 beautiful granddaughters, and the treasurer of <u>PFLAG Cleveland</u>, a local chapter of the National nonprofit organization. PFLAG is the nation's largest organization dedicated to supporting, educating, and advocating for LGBTQ+ people and those who love them. Our chapter has been active in this effort in the Greater Cleveland area since 1985. Each year of my involvement, I encounter scores of new parents who share their personal stories of their children's gender identity. Whether a child or an adult, each family begins with its fears of harm that could come to them. Our support group, led by volunteer social workers and a psychologist help these families move from fears and overt threats from uncaring individuals, to acceptance and love. These familes and the LGBTQ+ indivividuals need our collective help, not government interference leading to legislative discrimination and hatred.

Therefore, I write to oppose HB6 which would ban trans athletes from participation in organized school sports. In my opinion, I believe this proposed ban would be harmful to young, gender-diverse students and the families that love them.

I urge members of the House to reject this bill based upon the harm it will bring to a minority population in Ohio.
