## Chesapeake High School March 23, 2023

Chairwoman Richardson, Ranking Member Isaacsohn, and members of the House Finance Subcommittee on Primary and Secondary Education, I appreciate the opportunity to speak before your committee.

My name is Avonn Booker and I am a sophomore from Chesapeake High School speaking to you today as an interested party on the Fair School Funding Plan.

I would like to talk about the Fair School Funding Plan and its potential to provide more of a level playing field in regard to physical fitness classes, extracurricular activities, and sports. I know the first thing that comes to mind when thinking about school funding is academics, but I know for many of my friends gym, extracurriculars, and sports are what make them want to attend school.

I moved to Chesapeake during middle school and the school I came from had a lot more access to sports and equipment. I like learning, but many of my friends only want to be at school because of sports. We live in an area where kids are vaping and often exposed to drugs, and sports help keep students busy and away from drugs. If a student is in the weight room or at practice, then that is less time on a video game, lessens their chance of doing drugs, or getting into trouble.

When visiting other schools and communities outside of our county, I am amazed at their facilities and equipment. There are huge community centers, pools, lacrosse, hockey, outdoor fields stretching on and on, and several schools even have turf on their baseball fields.

We raise money through donations, car washes, spaghetti dinners, and rummage sales for basic equipment and uniforms. We don't have the extras, we work to have just enough.

For example, last year our purple and white Panther football team had to wear red helmets, borrowed from another district, in order to play. Our players were made fun of and embarrassed, but kept working hard. Our volleyball team raised money for their own jerseys and the Athletic Boosters, teams, and community members had to chip in for us to have access to our game film and stats platform. Without Fair School Funding, many of our programs won't be able to continue. When adding up fees for officials, transportation, coaches, and equipment, many of our sports lose money each year. Families can't afford to attend sporting events because for a family of four, it is \$20 a game. If a team plays two or three nights a week, many families have to divide up and one parent attend each game because they can't afford for the whole family to watch.

If poorer, public schools, like ours, have more funding, then there is the potential that athletic departments can continue to provide student athletes with programs that motivate them to try hard and give their best effort on the field and in the classroom. There is also the potential that coaches can focus on the athletes and the games instead of worrying about fundraising.
