Koral Clum

Koral has been practicing forestry in Ohio since 1980. She was employed from 1980-1985 with ODNR, Division of Forestry at Shawnee State Forest as a Management Forester, 1985-2000 ODNR, Division of Forestry Service Forester serving Tuscarawas, Holmes, and Wayne Counties, and 2000- 2020 – Clum Forestry Consultants. Koral currently serves on the Ohio's Forest Advisory Council and was a previous member of the Governor's Reclamation Commission.

She is a graduate of Iowa State University, with a Bachelor of Science in Forestry awarded in 1980. Koral is a Certified Forester, administered by the Society of American Foresters. Memberships include the Society of American Foresters and the Association of Consulting Foresters. Koral and her husband Randy own a 152 acre Certified Tree Farm in Harrison County, Ohio. Their Tree Farm was designated the 2017 Outstanding Ohio Tree Farm of the Year and the 2018 National Outstanding Tree Farm of the Year (there are 74,000 tree farms in the United States). Other activities include: Ohio Forestry Association member and past or present Board Member, East Central Ohio Forestry Association member and past office holder. The "Forester of the Year Award" for the 20 state Northeast Area of Forest Resource Program Leaders was awarded to her in 1996.

Clum Forestry Consultants managed properties for hundreds of forest landowners in East Central Ohio. CFC marked, helped sell, and administered the harvest of three to four million board feet of timber each year. Over twenty plus years, they sold more than 70 million board feet of stumpage to various sawmills. Koral has served as an expert witness in timber trespass cases and has done countless timber appraisals and long term forest management plans. The goal was always to promote science based forest management in Ohio's woodlands.

Since retiring in January, 2022, Koral has been spending more time at Hepatica Falls Tree Farm, volunteering, and enjoying time with her family, from five months old to age 90.
