Big Spring Township has submitted a Resolution to support S.B. 119. All three Big Spring Trustees support the Resolution. Two Trustees have signed the Resolution, the third supports the Resolution but wasn't able to sign it because of a vacation commitment.

As outlined in the approved and submitted Resolution, Big Spring Township supports S.B. 119 for the following reasons;

- -Concerns/fears over contamination of soil, ground water, aquifers, and air quality, in and around the SFL property.
- -Concerns about run off of contaminated rain and melting snow/ice that runs through the waste in uncovered rail cars and onto and into the ground and ground water.
- -Concerns/fears about the harmful effects to the environment for future generations if the liners fail and cause pollution and contamination.
- -The decline in property values that are in close proximity to the landfill.

Big Spring Township also supports S.B. 119 for the following reasons not listed in the Resolution;

- -Sunny Farms Landfill is currently mining stone directly South of the South mountain of landfill trash.
- -Rail cars full of trash blocking R.R. crossings on Seneca County roads.

I would like to thank you for allowing me to speak. Big Spring Township wholeheartedly supports S.B. 119 and we ask for your committee to support it as well.

- -Concerns/fears about the harmful effects to the environment for future generations if the liners fail and cause pollution and contamination.
- -The decline in property values that are in close proximity to the landfill.
