Testimony on SB 205

Chairman Brenner, Vice-Chair O'Brien, Ranking Member Ingram, and members of the Senate Education Committee, thank you for the opportunity to submit testimony on SB 205. I am submitting this testimony on behalf of the ADAMHS Board of Adams, Lawrence, and Scioto Counties. We are the Alcohol, Drug Addiction and Mental Health Services Board of Adams, Lawrence and Scioto Counties, and are statutorily empowered to establish, to the extent resources are available, a community support system, which provided prevention, treatment, support and rehabilitation services for our community.

I am submitting this testimony in support of SB 205 and the proposed inclusion of language that requires the instruction in the harmful effects of and legal restrictions against the use of drugs of abuse, alcoholic beverages, and tobacco provided under a school district's health curriculum to be given annually, be developmentally appropriate, and include information on the harmful effects of the use of illicit exogenous substances.

In our three county areas, per the OH YES Surveys 2021-2022, we have seen a rise in alcohol, vaping and marijuana usage in 11-14 year olds. In Adams County, the highest percentage of alcohol use was 11-12 year olds at 26.26%, the highest percentage of marijuana usage was 13-14 year olds at 35.19% and overall usage of vaping was at 35.51%. In Lawrence County, the highest percentage of alcohol use was 13-14 year olds at 11.39%, the highest percentage marijuana usage was 13-14 years olds at 37.06% and overall usage of vaping was at 25.49%. In Scioto County, the highest percentage of alcohol use was 11-12 year olds at 26.38%, the highest percentage marijuana usage was 13-14 year olds at 47.83% and overall usage of vaping was at 23.65%. Prevention funds are one of the smallest pots of funds we receive, however we have contracted with three of our providers to provide prevention education in the schools in all three of our counties. They have been able to implement Vaping programs, Substance Use education, Life Skills and many other programs to educate our youth on the harm of using many of these substances. However, we do not receive enough funds to place these programs in all of our school systems.

I strongly believe that incorporating the addition of Prevention training on all Substance Use annually in a developmentally age appropriate way in their health curriculum in schools would be very beneficial. Unfortunately we are seeing many younger children experimenting with Substances at an earlier age at an alarming rate. We need to target our children at earlier stages in their life to prevent the use of harmful substances, if we wish to stem the tide of our overwhelming drug abuse.
