Steve Moore is a successful entrepreneur, an attorney specializing in environmental law, and has a background in plastics engineering technology and chemistry. He is Chief Executive Officer of Veolia Nuclear Solutions - Federal Services (VNSFS) delivering innovative technologies, robotics, engineering, waste operations and infrastructure services to the federal government, VNSFS was formed in January 2018, after Veolia purchased a portion of Wastren Advantage, Inc. (WAI), a business that Mr. Moore had owned and operated since 2006

Under Mr. Moore's leadership, WAI grew from a regional firm with less than 50 employees into a multi-faceted corporation providing complex facility management and environmental remediation for the federal government to chemical processing and manufacturing, construction/design services and property development. WAI increased sales and profitably throughout Mr. Moore's leadership and grew to employ hundreds with offices throughout the U.S. WAI's success was achieved through strategic partnerships, organic growth, and key acquisitions. The company was recognized multiple times as Contractor of the Year for the US Department of Energy, was one of the fastest growing for-profit companies in the US for INC Magazine, was featured in several publications as well as received many community awards

Additionally, Mr Moore is an owner in WAI Construction Group (WAICG) supporting operations at the Department of Energy site in Piketon, Ohio, working with NASA and other federal agencies and building school and hospitals. He also owns commercial property management company, WAI Properties. During Mr. Moore's career, he founded Performance Specialty Chemicals in Columbus which was purchased by a publicly traded chemical company in September 2022 and Selective Micro Technologies.

He is a founding member of two private equity companies: the Tri State Angel Investment Group (TSAIG) investing in startups from Southern Ohio, Eastern KY, and western West Virginia; and the Daniel Investment Group, focused on faith-based and community enterprises nationally. Together, the private equity funds helped start up over 20 businesses in the region

Mr. Moore has been a special advisor to multiple Ohio Governors on economic issues in Southern Ohio and has testified before US. House committees on the effectiveness of the DOE nuclear cleanup program. Mr. Moore is a guest speaker and keynote speaker at



conferences nationally and internationally on subjects ranging from economic development, entrepreneurship, environmental justice, and leadership.

He was recently appointed to the board of a privately held fire retardant manufacturing company in Chicago and has served on several boards including the Appalachian Partnership for Economic Growth (APEG), Shawnee State University, and nonprofits such as Elizabeth's Hope Crisis Pregnancy Center, the Pike County YMCA, among others.

With his wife, Mr. Moore started the Jennifer and Steven Moore Foundation in 2018 as a 501(c)(3) nonprofit with a specific mission of helping solve the challenges of poverty in the Southern Ohio region. Since then, the foundation has funded initiatives with the Portsmouth Children's Museum, the Pike County Partnership Against Domestic Violence, addiction recovery facilities, and supported the expansion of the SOMC Hospice as well as funded the startup of a local church.

Mr. Moore has an AAS in Plastics Engineering Technology and a BS in Natural Science from Shawnee State University, a Juris Doctorate from Capital University Law School with a specialization in environmental law. He is licensed to practice law in Ohio Mr. Moore completed an Executive Education Program at Harvard Business School. He resides in Otway, Ohio, with his wife Jenny
