Regarding City Connects Pilot Program

May 31, 2023

Chairman Dolan, Vice Chair Cirino, Ranking Member Sykes, and members of the Ohio Senate Finance Committee,

My name is Jillian Lain, and I am the Director of City Connects Midwest from the Marian University Center for Vibrant Schools. We are here today to ask members of the Senate and this committee to build upon and support the existing \$1 million commitment by the House. The pilot program contained in the House version of the budget is designed to expand the City Connects program in at least 32 K-12 schools in Ohio; however, to fully implement this pilot we are seeking an additional \$9 million out of a \$10 million initial ask. Following this pilot project, schools will have the ability to sustain implementation because City Connects is already a named allowable use of the Student Wellness and Success Funds. Additionally, many schools utilize federal Title 1 & Title 4 funds to provide ongoing support for the program once the pilot funding concludes.

In the Fall of 2008, City Connects launched in a Catholic elementary school in Dayton, Ohio. Over time, City Connects expanded and is currently implemented in seven Ohio schools across Dayton and Springfield, including four parochial schools, two charter schools, and one public school. As a part of my role, I work collaboratively with Boston College to support the implementation of City Connects in these Ohio schools and have seen the impact firsthand.

What makes City Connects unique is that every child can benefit—not just the students in need of crisis intervention. In the 2021-22 school year, City Connects in Ohio served more than 2,600 students from early childhood through high school. A City Connects coordinator created and implemented individualized student support plans for 99% of students. These plans ensure students can receive appropriate support, including prevention and enrichment services like after-school programs, early intervention services like behavioral interventions, and intensive crisis intervention services like mental health services. In this same academic year, 26,089 services were delivered by more than 100 Ohio community partners, with 93% of students receiving three or more services.

Additionally, in the 2021-22 academic year, Boston College partnered with the Marian University Center for Vibrant Schools to establish the City Connects Midwest Technical Assistance Center. The TA Center ensures students in the Midwest can benefit from one of the nation's most rigorously evaluated and effective approaches to student support. Since 2021, City Connects has been implemented in nearly 80 schools in Indiana in the last 2 years through various city and state funding sources. The initial data is proving very promising, and we are eager to continue to expand City Connects in Ohio as well.
