SENATE FINANCE COMMITTEE TESTIMONY Kerry Lee Pedraza Executive Director, United Way of Clark, Champaign & Madison Counties May 31, 2023

Chairman Dolan, Vice Chair Cirino, Ranking Member Sykes and members of the Senate Finance Committee, thank you to provide testimony in support of Substitute House Bill 33. I am here today to discuss HB 33's budget provisions regarding the United Way Collaborative.

My name is Kerry Lee Pedraza and for the past nine years I have had the privilege of leading the United Way of Clark, Champaign & Madison Counties as the Executive Director and Chief Executive Officer. Prior to my work at United Way, I served as the Assistant Director of the Clark County Department of Job and Family Services. I was very proud of the work that was accomplished during my tenure as Assistant Director at Job and Family Services and continue to be grateful for your stewardship of public resources that assist our most vulnerable citizens in our three counties. In my position as CEO at United Way of Clark, Champaign & Madison Counties, I have a unique vantage point to be able to witness the incredible work that can occur through strong collaborations and partnerships when public, private and nonprofits work together to create even greater impact.

I ask you to support a \$1.8 million per fiscal year appropriation to directly support the United Way Collaborative. Investing in the United Way Collaborative goes far beyond supporting communitybased programming that will improve the lives of thousands of Ohioans. This annual appropriation will serve as a critical catalyst for six United Ways to mobilize additional financial resources from business, individuals, and foundations. Specifically, this appropriation will allow additional access to effective, evidence-based literacy programs and additional case management services.

The three counties that I serve, Clark, Champaign, and Madison, are reflective of the diversity across this state: urban, rural, ethnicity and levels of poverty. As diverse as these counties are on many levels, one thing that all three share is poor literacy levels and lack of kindergarten readiness.

We are grateful for the work that is already taking place within the homes of our children, on the laps of parents and grandparents that read and carry on conversations with their kiddos, childcare centers, preschools, and school personnel that work tirelessly on behalf of our most vulnerable population. But, it is not enough. Nearly 37% of children in Madison County do not test at a level indicating they are ready for kindergarten, 83.5% in the Urbana City School District and 85% of children in the Springfield City Schools.

This appropriation will provide six United Ways across ten counties to do more collectively to expand, replicate, scale and/or enhance programs and strategies that are making the greatest impact. Together, our Collaborative will create a collective impact model that encourages efficient

and effective practices to be shared with economies of scale to be used across all partnering agencies.

As you can imagine there is not a one size fits all when moving the needle on kindergarten readiness because of the many variables involved. As part of this appropriation, flexibility for much needed case management is included. Kindergarten readiness not only involves working one-on-one with children but many of our most successful programs in Clark, Champaign and Madison Counties involve working directly with parents or other caregivers to ensure that they, to have the tools necessary to reinforce, encourage and model skills and practices needed to be successful when entering kindergarten.

With the additional funding that would be provided through this appropriation, successful programs like the SPARK, FAST, Kindergarten Readiness Camp and Reading Enrichment Programs can be expanded to allow for more participation in our three counties. We know that these programs work. The most recent data from the SPARK program indicates that 32% of the children involved in the program moved out of the Below Average category in reading and 48.1% of the children scored Above Average by the end of the program. We know these programs work, but additional funding is necessary to grow this and other successful programs.

The state of Ohio continues to invest in attracting and preparing a work ready workforce. A work ready workforce doesn't begin in middle and high school. It begins at the cradle where research shows that brain development is at its strongest. Literacy and Kindergarten Readiness is the foundation to creating a strong Ohio workforce. This is a small investment that will pay dividends in the future.
