HB 89 Enter the Cosmetology Licensure Compact

Dear Ranking Member Paula Hicks-Hudson, Vice-Chair Antani, and members of the government Oversight Committee,

May name is Ladosha Wright. I am a 23-year licensed cosmetologist, salon owner, and 10-year industry educator.

From the looks of everyone's head in this room, the meticulous shaved heads, beards, haircuts, and hair color are evident that you all inherently know that barber and beauty education that yields quality matters in this great state of Ohio,

But the introduction of HB 89 implies less education is all one really to work on hair. It is to my understanding this bill is borne out of the request to give access to those licensed professionals serving in the armed forces and their spouses who worked licensed in other states to work in Ohio.
