Julie A. Weagraff, MNO, CFRE

Julie A. Weagraff is the Chief Development Officer for Girl Scouts of North East Ohio and has worked for the council since 2015. She oversees a staff of five and is responsible for all fundraising and advocacy activities for the council, which covers 18 counties across Northeast Ohio and serves over 18,000 girl members and 9,000 adult members. She secured the council's first two capital grants from the State of Ohio and is currently leading a \$7 million capital campaign to build a STEM Center of Excellence that will provide unique, hands-on STEM learning experiences for Girl Scouts and students across the Northeast Ohio region.

Ms. Weagraff has worked in the nonprofit management field for 30 years and has expertise in planned giving, major gifts, capital campaigns, annual giving, corporate and foundation relations, board governance, special events, volunteer management, marketing, communications, brand strategy, legislative advocacy, and alumni relations. She has held leadership positions at several higher education institutions including Case Western Reserve University, the Ohio Foundation of Independent Colleges, and Cuyahoga Community College.

She holds a master's degree in nonprofit management from Case Western Reserve University and a bachelor's degree in public relations with honors from Westminster College in New Wilmington, PA. In 2014 she attained the Certified Fund Raising Executive (CFRE) credential, which is recognized worldwide as the global standard for the fundraising profession. She currently serves as Immediate Past President of the Board of Trustees of the Northern Ohio Charitable Gift Planners. Ms. Weagraff also serves on the Board of Directors of the Greater Akron Musical Association, the Estate Planning Council of Cleveland, and is Vice Chair of the Leadership Council of the Cleveland Leadership Center. In 2022 she was elected to the Association of Fundraising Professionals Global Nominating Committee, representing Ohio and Pennsylvania. In 2021 she served as a Mentor for the Alford Group Mentoring and Leadership Development Program. She is a member the Government Affairs Committee of the Greater Akron Chamber of Commerce, the Association of Fundraising Professionals Greater Cleveland Chapter, ATHENA Akron, and is a member of Leadership Cleveland's Class of 2024.

She has served on committees for Girl Scouts of the USA including the National Alum and Lifetime Member Advisory Committee, National Convention Sponsorship Committee, National Philanthropy Conference Committee, and the National Episodic Volunteers Thought Partner Committee. She is a graduate of Leadership Akron (Class 37), Cleveland Leadership Center's Civic Leadership Institute, the Women's Network Community Leadership Institute, the Mandel Leadership Development Program, and Leadership Lake County. She is a past member of the Board of Directors of Westminster College, the Greater Cleveland Chapter of the Association of Fundraising Professionals, and Girl Scouts of North East Ohio.
