Sponsor Testimony

Senate Bill 56

Ohio Senate Health Committee

March 22nd, 2023

Chair Huffman, Vice-Chair Johnson, Ranking Member Antonio, and Members of the Senate Health Committee, thank you for the opportunity to provide sponsor testimony on S.B. 56, which upon enactment would join Ohio to the “Interstate Massage Compact.”

The Interstate Massage Compact (“IMpact”) is an interstate occupational licensure compact for massage therapists. As this committee knows, an interstate compact is a contract among two or more states which creates an agreement on a particular policy issue, adopting a certain standard, allowing them to cooperate on regional or national matters.¹ States joining compacts agree to recognize a license issued by another compact member state via “Authorization to practice”. An “authorization to practice” simply allows the massage therapist to practice in all compact states/territories with one license issued by the Compact, eliminating the costly and time-consuming practice of obtaining single-state licenses in each state of practice.

The “IMpact” is similar in form and function to other compacts this Committee has considered, in that a massage therapist must hold an active, unencumbered license in a compact member state to be eligible to apply for compact privileges and obtain a multistate license. These practitioners must also pass a background check and meet other eligibility requirements related to education and examinations. From a regulatory standpoint, there are no changes to each compact member state’s authority to protect public health and safety through the existing state regulatory structure – a licensee practicing under compact privilege must abide by the laws, regulations and rules for the state in which they are located.² To summarize “IMpact allows massage therapists who maintain an active, unencumbered license in the compact member state where they reside to apply for a multistate license. After verifying eligibility, the massage therapist is granted a multistate license which authorizes practice in all other compact member states. The massage therapist must maintain their “home state” license in good standing.”³

The “IMpact” is still in its formative stage, with a stakeholder group forming in 2021 and gathering feedback throughout 2022. This group consisted of industry representatives from multiple states, including the Ohio Chapter of the American Massage Therapy Association, who worked collaboratively with the Federation of State Massage Therapy Boards (FSMTB), the Department of Defense (DOD) and others to develop model language. This model language was released in late 2022 and, similar to other compacts before it, stipulates that the IMpact will take effect when seven states enact enabling legislation.⁴ These first seven states will establish the base rules for the compact, and states that join after this date are subject to the rules of the Commission as they exist on the date when the compact becomes law. Ohio’s massage therapy industry worked proactively during the development process of this compact, and it would be wonderful if Ohio could be one of the first seven in order to keep that seat at the table.

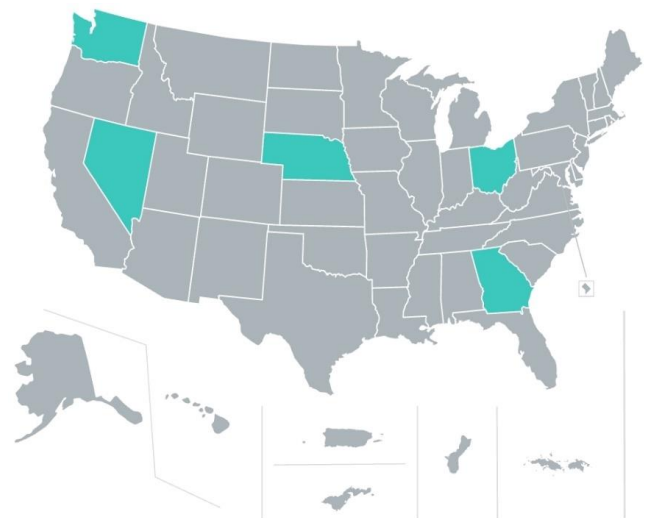
Currently, four other states have introduced enabling legislation: Washington, Nebraska, Georgia, and Nevada.⁵ All the bills are moving, with Nevada Senator Melanie Scheible (D) testifying on her bill later today.⁶

The lack of occupational licensure reciprocity is a real barrier for individuals seeking to move across state lines. Researchers at the University of Minnesota found that the interstate migration rate for individuals in occupations with state-specific licensing exam requirements is 36% lower relative to those in non-licensed occupations.⁷

The IMpact makes life easier for these military families by allowing the service member or their spouse to continue to work with their current compact privilege if the military family is assigned to a new duty station in a compact member state.

Overall, the IMpact will support military families, improve access to and continuity of care for Ohio residents, and increase license portability for the over 11,000 massage therapy professionals based in the Buckeye State⁸, while maintaining the current high level of care.
