I served as a member of the multidisciplinary treatment team on the inpatient psychiatric unit with children aged 2-12; facilitated daily individual and group therapy developing communication and coping skills and completed family therapy sessions promoting change in family dynamics, providing parent education, and making community referrals for resources and outpatient providers; I worked as needed in the intake department completing assessments in the emergency department determining diagnoses and level of care for treatment consulting with the unit psychiatrist.

I worked as needed in the partial hospitalization program with children and adolescents aged 5 to 18 with mental health and behavioral problems facilitating therapeutic groups and family sessions; answered inquiries, provided referrals, and completed clinical assessments and admissions.

### ***Cook Children's Medical Center-Program Specialist, March 2006 – September 2012***

I worked as a member of the multidisciplinary treatment team on the inpatient psychiatric unit with children aged 2 to 12 assisting with activities of daily living, maintenance of a safe environment, and management of harmful behaviors; participated in family crisis intervention and facilitated skills and parent education groups; as a LMFT-A and LPC-I under supervision I served as needed as a family therapist on the inpatient unit and in the partial hospitalization program.

### ***Denton County Friends of the Family-Family Services Specialist/Coordinator, October 2003 - February 2007***

I worked and supervised the family services department in 3 positions over 3 years working with grants from the Texas Department of Protective and Regulatory Services providing in-home services to clients and families to improve parenting, homemaking, and life skills; coordinated and facilitated community parent education classes; maintained documentation and contact with Child Protective Services staff.
