Chairman Huffman, Vice Chair Johnson, and Members of the Senate Health Committee:
Thank you for hearing my support testimony for HB 73, **The Dave and Angie Patient and Health Provider Protection Act.**

I am writing on behalf of loved ones lost... both family and friends during the Covid protocols. I'll try to be brief with each of the stories of family, friends and family of friends.

Story 1. Spring 2020. My Choir friend Tammy's father, a US Veteran died alone in a nursing home, denied from seeing his loved ones. Prior to the lock in and isolation, he was healthy and thriving. I emailed Gov. DeWine on this families' behalf. The family tried to have him removed from the home to care for him themselves. They were denied. Tammy is a nurse and her husband a Doctor. Dad died alone in May of 2020. Happy Memorial Day and thank you for your service to our country, Sir.

Story 2. "Mr. S" My best friend's Father in Law got covid, was put in a hospital, given the protocols of remdesivir, and a ventilator. My friends were on route back from FL to OH and were unable to stop this from occurring, despite being a dentist and well educated family, Mr. S died in hospital alone, ventilated and not given the requested Ivermectin.

Story 3. Summer 2021. A casual acquaintance from the local pool Carol. Carol had been a lively and active, vibrant, healthy, normal person until receiving the Covid shot. Soon after she was injected, she fainted, hit her head and was subsequently experiencing vision loss. When I saw her she had to be guided in and out of the pool, supervised and wearing side blinder sun glasses like a horse.

Story 4. Summer 2021. A very close family member had sold the family home, taken a new job, and began the process of a new build. His new employer required that he take the shot. Being between a rock and a hard place, he did. He nearly died immediately. Spiking a high

fever, shaking violently, vomiting and telling his wife “I’m going to die”. Very thankfully his wife and their 4 year old son did not lose him. He recovered via some intense detox therapies.

Story 5. Uncle George was vibrant, relatively healthy older adult who developed prostate cancer. The prognosis was very good. He was to go in for a procedure on a Monday with a greater than 90% chance of success. Ahead of the procedure he was required to take the covid shot in order to have the procedure, which he did. That weekend, ahead of the Monday appointment, after receiving the injection he fainted, hit his head on the stove, went into a coma and died.

Story 6. Coach Tracy from my community, also my age, went into the hospital with covid and never came out. My understanding is he was given Remdesivir and put on a ventilator.

Story 7. Spring 2022. My daughter’s friend Heather’s husband Matt died shortly after receiving the Covid shot. Heather was 38 and Matt was very close to that age. He left behind two preschoolers, a young elementary school aged child and two other children from a prior marriage.

Story 8 My dear friend Bob’s close buddy Ed got Covid. He was encouraged by others to go to ER. He was put on Remdesivir, sedated, ventilated, and died in Medina hospital system. Ed was in his mid 50’s. Ed was denied Ivermectin.

Story 9 November 2022, my Brother in Law had been experiencing fainting spells. I believe these began after receiving the covid shots. In October of 2022, Gary fainted and fell down the wooden steps of their split level home, went into a coma, was taken to the Cleveland Clinic, ventilated and died within a few weeks. We were told he had covid. We were told it was ok to visit him as long as we wore a mask, a gown and gloves.

Story 10. April 1 2023. Nana. Nana was a vibrant, reasonably healthy active 85 year old.... until she got the covid shots. Her 5 year remission cancer returned, turbo style and she was soon diagnosed with a brain tumor and died.

I hope and pray that for the memory of these people. These loved ones you will vote YES on HB 73. You will allow those medical Doctors to give life saving care to their patients and stop the insanity.
