Chair Manning, Vice-Chair Reynolds, Ranking Member Hicks-Hudson and members of the committee, thank you for the opportunity to offer proponent testimony on SB 37, a measure to limit the use of driver license suspensions for conduct unrelated to operating a vehicle. My name is Kevin Werner and I am the policy director at OJPC. We are a nonprofit law firm with offices in Cincinnati and Columbus, whose mission is to promote fair, intelligent, and redemptive criminal justice systems.

The bill corrects driver license suspension policies as related to four categories of offenses: dug offenses, failure to pay child support, truancy and failure to show proof of financial responsibility. The common thread between offenses is that each will trigger suspension of a driver license. On a practical level, this legislation will help ensure people can go about their lives without needless barriers preventing them from getting to work, showing up for medical appointments, and driving their kids to school.

The Ohio Justice & Policy Center supports policy reforms that reign in runaway sanctions that arise because of a conviction, especially those where sanctions have no nexus to public safety or any recognizable relationship to the conduct. Debt-related suspensions are not an indication that a person is unable to safely operate a vehicle. They are an indication of poverty, and this bill intelligently recognizes that connection.

Driver license suspensions are one example of an entire universe of consequences—collateral sanctions—which prolong punishment, often in counterproductive ways, for baffling reasons. According to the National Inventory of Collateral Consequences of Conviction, Ohio has 1,348 consequences in the Revised or Administrative code that impact a person after a felony or a misdemeanor conviction¹. There are 485 sanctions held in 256 provisions that trigger when a person is convicted of or pleads guilty to an offense related to controlled substances (Table 1). Suspending a driver license need not be one of them.

Ohio has a long way to go toward modernizing and eliminating unnecessary collateral sanctions (See Table 1). This bill is an important step but cannot be the last step. OJPC is grateful to Senators Blessing and Ingram for introducing this practical, commonsense bill. I am happy to answer questions.
