STEVE BOYMEL

Steve Boymel attended Ohio University and has been practicing Nursing Home Administration since 1968. He holds an administrators license with the State of Ohio.

After obtaining his Administrator's license, Steve became the Administrator of Garden Manor Care Center and held that position until 1980. In 1980 Steve ventured into the Developmental Disability field and developed and built Brookside Extended Care, a Nursing Home for developmentally disabled children. In 1987 he designed, built and developed Brookwood Retirement Community, a 250 unit full Retirement Community.

Steve also owns and operates Ohio Valley Manor, a 157 bed Nursing and Assisted Living Facility in Ripley, Ohio; Loveland Health Care Center, a 99 bed Nursing Facility; The Alois Alzheimers Center, a 97 bed all Alzheimers Nursing and Assisted Living Facility which was the first free standing all Alzheimers Center in the United States; Covenant Village of Green Township, a new 107 bed physical therapy rehabilitation center; Florence Park Care Center, a 150 bed Nursing Facility; and Arlington Pointe, a new 107 bed physical therapy rehabilitation center.

He is Chairman of the Board of Hospice of Southwest Ohio, and he is a minority owner of Stay Well Home Health, a home health company. Steve is also a past recipient of the Ohio Health Care Association Pioneer Award.

In 1980 Steve and several other area Nursing Home operators formed a trade association, the Ohio Academy of Nursing Homes. For several years he was the Legislative Chair.

His public service includes serving on numerous governor's task forces to study and recommend legislation to help set public policy in the Nursing Home Industry as well as the Mental Retardation Developmental Disabilities profession.

He has been Chairman of the Legislative Committee of the Ohio Health Care Association and the Ohio Health Care Association and served on the Workers Compensation Service Corporation Board. He has also served on the Labor Committee of the American Health Care Association.

Steve is currently a Board Member of the Holocaust & Humanity Center.

Steve is also Chairman of the Board of Resurge Recovery, a new modern outpatient substance use disorder facility.
