RE: Opposition to S.B. No. 117 - Establishment of the Salmon P. Chase Center for Civics, Culture, and Society and the Institute of American Constitutional Thought and Leadership

Instead of diverting resources to establish new entities, I urge you to focus on providing additional support to existing programs and initiatives at the University of Toledo College of Law. This could include increasing funding for scholarships, expanding legal clinics, and enhancing career development opportunities for students. By investing in these areas, we can better serve the needs of a broader student population and address the challenges they face in their legal education and careers.

I am proud of the strong student community that exists at the law center, as well as the discussions that are already fostered there. We have incredible future attorneys honing their craft during a very challenging time in their lives, and I would love to see what a bill could do if it focused not on branching out into a new venture that distracts from more critical, current issues, but on determining what the school's strengths are and working to amplify them to draw more students and lay a foundation to rebuild the school's waning reputation upon.
