1. Are you a graduate of or do any of your dependents attend the institution to which you are being appointed as trustee?

ANSWER: Yes, I am a graduate of Bowling Green State University, 2002.

2. What is your position on the First Amendment rights of faculty, staff, and students, and how will you balance this with promoting diversity of thought on campus?

ANSWER: Free speech, religion, and the press is a cornerstone of our Democracy and all students, staff, and citizens of the U.S. have a right to express their opinions in a *lawful* manner and even though an opinion may be unsavory or unpopular, even disgusting, our college campuses should be a beacon for broad thought and discussion (hopefully in a respectful manner) that encourages understanding and personal/professional growth.

3. In your opinion, what are three current significant issues affecting higher education?

ANSWER: Three significant issues affecting higher education are:

- 1. Workforce: Ensuring students have the technology, training, and access for tomorrow's jobs today
- 2. Costs: Helping all students succeed with a strong education/training that they can afford
- 3. Post-COVID19 Impacts: What effects the COVID19 pandemic had on kids K-12 and now entering college I think this is an emerging and important issue to not ignore and can also be under mental health, absenteeism, graduation rates, test scores, but will need to do more research on this topic.
- 4. Do you feel comfortable presenting new or alternative solutions to issues presented to the Board of Trustees ("Board") by the president or other trustees of the institution to which you are being appointed?

ANSWER: Yes, I believe in an open dialogue on the Board and with the President and their team.

5. What are some ideas you plan to propose to reduce the overall cost of higher education?

ANSWER: I will need to do more research on this topic. I would like to hear from the local business community and how they — in partnership with the community and University — may be able to offer financial support in exchange for internships and co-ops.

6. What thoughts do you have on faculty tenure, post-tenure review, and annual faculty performance reviews?

ANSWER: As in business, I think it is reasonable to measure success on performance – and tenure being something earned through strong performance, but I would need to study the issue more closely in the coming months as I onboard.

7. What are your thoughts on ways to increase graduation rates at the institution to which you have been appointed?

ANSWER: I'd like to research this more with BGSU thought-leadership before providing commentary.

8. Is higher education in Ohio addressing the current and future workforce needs of our state, and how can the institution you have been appointed to better address these workforce challenges?

ANSWER: I am looking forward to diving in with President Rogers and the Board and hearing about all the opportunities we have not only for BGSU, but also the state. The DeWine Administration, General Assembly, and JobsOhio continue to work hard on addressing this paramount issue — I understand the great need to develop and retain our graduates — we should be working as closely as we can with the business community and industry organizations (Ohio Chamber, NFIB, OBRT, Farm Bureau, Building Trades) to focus our efforts in a unified approach that utilizes our strengths (BG's close proximity to the tri-state region and strong manufacturing base to name two). I also think it is critical we build out our research and development capabilities at BGSU that will spin out the businesses and technology of tomorrow in NW Ohio.

9. In your view, who are you ultimately responsible to serve as a trustee of the institution you have been appointed to: the president, Board chairperson, or taxpayers of Ohio?

ANSWER: My job ultimately is to serve the people of Ohio and the students and parents who entrust their daily lives and hard-earned dollars to a state school to provide an education and to prepare them to be successful in whatever endeavor they pursue. My personal view is any educational Board of Trustees and President should share this passion of service first for the future of our state and nation.
