1.	Are you a graduate of or do any of your dependents attend the institution to which you are being appointed as trustee?

2.	What is your position on the First Amendment rights of faculty, staff, and students, and how will you balance

	My position on the First Amendment rights of faculty, staff, and students is encouraging the right to free speech while acknowledging the appropriate platform to express those thoughts. I understand community colleges are open door institutions and that open access is important to our students and communities. Being exposed to different ideas and solutions will expand student thinking and enable problem solving from different perspectives without narrowing the focus on one or more opinions.
	In your opinion, what are three current significant issues affecting higher education?
	 Cost/Student Debt - Tuition increases that outpace inflation and increase student debt; Workforce Gaps - Not meeting industry employment needs; Aging Technology, Equipment, Facilities – Upgrades that help community colleges continue to offer hands-on training for the jobs that are coming (digital age AI, Manufacturing, Healthcare)
4.	Do you feel comfortable presenting new or alternative solutions to issues presented to the Board of Trustees ("Board") by the president or other trustees of the institution to which you are being appointed?
	My experience in Leadership within Lima Memorial Health System has allowed me opportunities to lead various strategic initiatives and challenge or offer differing ideas/solutions to those initially proposed. Additionally, I ensure I am fully knowledgeable in all aspects of the topic being proposed and engage in conversations to fully understand the matter.

5. What are some ideas you plan to propose to reduce the overall cost of higher education?

College Credit Plus (complete college courses in high school, at no cost, and finish a degree at a college/university)
Transfer Pathways (start at a community college and transfer to a university)

• Pathways with business and industry (e.g., paid work and learn, apprenticeships, internships)

6. What thoughts do you have on faculty tenure, post-tenure review, and annual faculty performance reviews?

While faculty tenure can show longevity and loyalty to an organization or college, I believe annual faculty performance reviews are important to ensure essential job duties and responsibilities are being met. Additionally, it is my understanding Rhodes State College conducts annual faculty reviews and believe these reviews are important to maintain accreditation and quality within all programs.

7. What are your thoughts on ways to increase graduation rates at the institution to which you have been appointed?

There are three areas in which I believe we can move students along their journey to graduating.

 Early Employer Connections - In today's changing educational delivery, it is important to connect students to employers as soon as possible. Engagement with employers can motivate students to complete a degree, because it is aligned with a potential job (example: internships)

Assessment and Data Analysis - As someone who works in a hospital setting, it is always important
to incorporate assessment and data analysis to identify at-risk students, courses in which students do not do well,
and institute improvement actions needed to progress toward graduation.

 Advocacy/Removing Barriers – Removing social/economic barriers (example: single parents raising families, while working full-time, finding financial support to assist them)

8. Is higher education in Ohio addressing the current and future workforce needs of our state, and how can the institution you have been appointed to better address these workforce challenges?

During early conversations with the Rhodes State College President, it appears Rhodes seems to be aligning itself with the long-term employment needs of business and industry. They are renovating facilities for Behavioral Services, Advanced Manufacturing, Artificial Intelligence, Agriculture Technology, and continue to advance their Health Sciences educational programs. They have worked closely with 10 county hospital administrators to redesign their curriculum for what was needed in their facilities and pushed to enable legislative changes enabling Rhodes to offer the BSN.

9. In your view, who are you ultimately responsible to serve as a trustee of the institution you have been appointed to: the president, Board chairperson, or taxpayers of Ohio?

As a member of Rhodes State College Board of Trustees, I am ultimately responsible for serving the taxpayers of Ohio, all while working in partnership with the president, chairperson, and other trustees.
