A confirmation hearing will not be scheduled until a completed questionnaire has been submitted. Once my office receives this information, we will work diligently to schedule your appointment on the Committee's agenda. 1. Are you a graduate of or do any of your dependents attend the institution to which you are being appointed as trustee?

Yes, I am a graduate of Bowling Green State University. I have no dependents attending BGSU.

2. What is your position on the First Amendment rights of faculty, staff, and students, and how will you balance this with promoting diversity of thought on campus?

I believe everyone has a right to their opinion and to express their opinion within the stated rules of the institution.

- 3. In your opinion, what are three current significant issues affecting higher education?
- 1 Declining enrollment/population cliff. Which is more dire in NW Ohio than other areas of the state.
- 2 The role of higher education in society (college degree, associates degree, trades degree, on the job training and the need for all of these types of education).
- 3 The cost of higher education and how it can be available equitably.
- 4. Do you feel comfortable presenting new or alternative solutions to issues presented to the Board of Trustees ("Board") by the president or other trustees of the institution to which you are being appointed?

Yes. Part of the role of trustee would be to look at issues from all sides and present alternatives.

5. What are some ideas you plan to propose to reduce the overall cost of higher education?

There is a need to look critically at the types of degrees offered. With enrollment declining, we will likely have to make hard decisions about the programs offered and some of those will need to be consolidated or eliminated.

6. What thoughts do you have on faculty tenure, post-tenure review, and annual faculty performance reviews?

Faculty tenure, post-tenure review and annual faculty performance reviews are all important components to a healthy academic environment. Some version of tenure is required to keep senior, high performing faculty at the university. However, that high performance needs to be evaluated and maintained through proper review. All faculty should be open to feedback and coaching through a minimum of an annual review process.

7. What are your thoughts on ways to increase graduation rates at the institution to which you have been appointed?

Graduation and timely graduation (four years or less for full time students) are important metrics to review and improve. Helping students succeed in their first year on campus is the first step toward improving graduation rates. At BGSU, the implementation of Life Design has been an encouraging step to helping students in their first year which should help in long term graduation rates.

8. Is higher education in Ohio addressing the current and future workforce needs of our state, and how can the institution you have been appointed to better address these workforce challenges?

In some cases yes, higher education is addressing workforce needs. In some cases, there is room for improvement. For example, "The Science of Reading" is important research that our future teachers need to understand and apply. Continually evaluating and improving the curriculum for teachers on how to teach (not just "this is how we've always done it") is necessary.

9. In your view, who are you ultimately responsible to serve as a trustee of the institution you have been appointed to: the president, Board chairperson, or taxpayers of Ohio?
