I believe tenure provides stability for institutions however believe that performance reviews should still be taken into account. It is imperative to do faculty performance reviews to determine if the faculty member is able to successfully communicate course objectives and foster student success. Performance reviews provide constructive feedback that can guide in professional development and teaching strategies.

7. What are your thoughts on ways to increase graduation rates at the institution to which you have been appointed?

Educating students on available financial aid, providing tutoring opportunities, emergency financial assistance programs and partnering with community organizations to provide additional resources such as housing, food pantries, and emotional support programs would assist students in overcoming difficulties that often lead to dropping out.

8. Is higher education in Ohio addressing the current and future workforce needs of our state, and how can the institution you have been appointed to better address these workforce challenges?

Yes, Ohio is addressing the workforce needs of our state. Southern State Community College actively reviews their programming to determine viability of classes and need for new, additional courses. For SSCC to be better in addressing these needs, more visibility needs to be given to community colleges and their ability to provide quality education. Creating collaborative programs with new industries would be beneficial to tailoring programs and facilitate internships and job placements.
