### INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 347** - Representative Jones.

To amend sections 5739.02 and 5739.03 of the Revised Code to presume certain trailers and vehicles are sold for agricultural purposes and thus exempt from sales and use tax when sold to established farmers.

**H. B. No. 348** - Representatives Seitz, Isaacsohn.

Cosponsors: Representatives Mathews, Upchurch, Galonski, Brewer, Somani, Abdullahi, Baker, Miller, J., Jarrells, Lightbody, Thomas, C., Sweeney, Robinson, Brennan, Forhan, Weinstein, Dobos, Carruthers, Denson.

To establish pilot programs to increase student attendance and graduation rates through financial awards and incentives, and to make an appropriation.

**H. B. No. 349** - Representatives Barhorst, Jones.

To amend sections 166.01, 166.02, and 5727.11 and to enact sections 122.161 and 122.162 of the Revised Code to authorize the creation of areas within which incentives are available to encourage the development of natural gas pipelines and other infrastructure and to make an appropriation.

**H. B. No. 350** - Representatives Callender, Troy.

To enact section 5534.664 of the Revised Code to designate a portion of State Route 44 as the "Lance Corporal Austin B. Schwenk Memorial Highway."

**H. B. No. 351** - Representative Young, T.

To amend sections 959.131 and 959.99 of the Revised Code to prohibit the abuse of a companion animal corpse.

**H. B. No. 352** - Representatives Baker, Carruthers.

To enact sections 103.55, 103.551, and 103.552 of the Revised Code to establish the Adverse Childhood Experiences Study Commission.

**H. B. No. 353** - Representatives Brewer, Mohamed.

Cosponsors: Representatives Brennan, Brent, Denson, Forhan, Hillyer, Miller, J., Weinstein.

To amend section 4509.05 of the Revised Code to require the Registrar of Motor Vehicles to include information regarding who is at fault for a motor vehicle accident on a motor vehicle abstract, when such information is available.

Said bills were considered the first time.
