The House met pursuant to adjournment.

**INTRODUCTION OF BILLS**

To amend sections 718.01 and 718.03 of the Revised Code to subject foreign temporary agricultural workers to municipal income taxes and to modify the withholding rules for such workers.

**H. B. No. 167** - Representatives Miranda, Abrams.

To amend section 109.804 and to enact section 109.791 of the Revised Code to modify the requirements for chief of police training and to allow advanced training for officers at or above the rank of sergeant and to amend the version of section 109.804 of the Revised Code that is scheduled to take effect December 29, 2023, to continue the change on and after that date.
