INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 169 - Representative Hillyer.

Cosponsor: Representative Brennan.

To amend sections 4713.50, 4713.51, 4713.64, 4731.14, and 4731.34 of the Revised Code to prohibit the provision of sun lamp tanning services to individuals under age 18 and to make changes regarding the titles that may be used by physicians.

H. B. No. 170 - Representatives Grim, Thomas, C.

Cosponsors: Representatives Abdullahi, Baker, Brennan, Brent, Brewer, Brown, Forhan, Galonski, Isaacsohn, Lightbody, Liston, McNally, Miller, A., Miller, J., Miranda, Mohamed, Robinson, Russo, Skindell, Sweeney, Upchurch, Weinstein.

To amend sections 109.57, 2923.125, 2923.128, 2923.1213, and 2923.13 and to enact sections 2923.26, 2923.27, 2923.28, 2923.29, 2923.30, and 2923.99 of the Revised Code to enact the Extreme Risk Protection Order Act to allow family members, household members, and law enforcement officers to obtain a court order that temporarily restricts a person's access to firearms if that person poses a danger to themselves or others.

(b) Thirteen horizontal stripes of equal height, the top and bottom stripe being black, and alternating white and black stripes in between, except that the eighth horizontal stripe from the top of the flag or emblem, which appears directly below the field of stars, is blue rather than white."
