## **INTRODUCTION OF BILLS**

The following bill was introduced:

**H. B. No. 359 -** Representative Young, T. Cosponsors: Representatives Hillyer, Jones.

To amend section 3902.50 and to enact sections 5.22108, 3902.63, and 5164.093 of the Revised Code to require health plan issuers and the Medicaid program to cover treatments and services related to Pediatric Autoimmune Neuropsychiatric Disorders Associated with Streptococcal Infections and Pediatric Acute-onset Neuropsychiatric Syndrome.

Said bill was considered the first time.

### **BILLS FOR THIRD CONSIDERATION**

Am. Sub. H. B. No. 51-Representatives Loychik, Schmidt.

To amend sections 2923.11, 2923.111, 2923.122, and 2923.17 and to enact section 2923.50 of the Revised Code to enact the Second Amendment Preservation Act to add additional protections to the right to bear arms, was taken up for consideration the third time.

The question being, "Shall the bill pass?"

Representative Dobos moved that **Am. Sub. H. B. No. 51**-Representatives Loychik, Schmidt, be re-referred to the committee on Rules and Reference.

The question being, "Shall the motion to re-refer be agreed to?"

The motion was agreed to without objection.
