**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 242** - Representatives Miller, A., Stein.

To enact sections 3333.46, 3333.461, and 3333.462 of the Revised Code to establish the Armed Forces Reserve Component Scholarship Program and related funds.

To enact section 5.2539 of the Revised Code to designate November 5th as "Roy Rogers Day."
