INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 121 - Representatives Robb Blasdel, Mathews.

Cosponsors: Representatives Roemer, Seitz.

To amend sections 718.02 and 718.82; to amend, for the purpose of adopting a new section number as indicated in parentheses, section 718.021 (718.17); and to enact new section 718.021 and section 718.821 of the Revised Code to allow businesses with remote workers to use a modified municipal income tax apportionment formula.

H. B. No. 122 - Representatives Pavliga, Miller, A.

To amend sections 2921.03 and 2921.04 of the Revised Code to expand intimidation offenses to include guardians ad litem and court-appointed special advocates.

To enact section 9.51 of the Revised Code to designate the Honor and Remember flag as the symbol of Ohio's concern and commitment to honoring and remembering the lives of all fallen service members and their families and to encourage that the flag be displayed at the Statehouse in Columbus on Memorial Day.

H. B. No. 124 - Representatives Galonski, Miranda.

To amend sections 2305.111, 2901.13, and 2933.82 and to enact section 2305.119 of the Revised Code to eliminate the period of limitation for the criminal prosecution of a person for rape and for a civil action brought by a

victim of conduct that would constitute rape and to extend the period of limitation for a civil action by a victim of childhood sexual abuse other than rape.

H. B. No. 125 - Representatives Mathews, Santucci.

To amend sections 5747.70 and 5747.78 of the Revised Code to modify the income tax deductions for contributions to 529 plans and ABLE accounts.

H. B. No. 126 - Representatives Mathews, Miller, A.

To amend section 718.01 of the Revised Code to expand a municipal income tax exemption for military pay.

H. B. No. 127 - Representative Fowler Arthur.

To amend sections 2151.011, 3301.0712, 3310.70, 3313.5312, 3313.5314, 3313.618, 3313.6110, 3313.6114, 3314.041, 3321.03, 3321.04, 3321.13, 3331.02, 3331.04, 3333.31, 3333.86, 3345.06, 3365.01, 3365.02, 3365.03, 3365.033, 3365.034, 3365.035, 3365.07, 3365.071, 5103.55, 5107.281, 5709.07, and 5747.72 and to enact section 3321.042 of the Revised Code to revise the law regarding the home education of children.

H. B. No. 128 - Representative Cutrona.

To enact section 5534.452 of the Revised Code to designate a portion of State Route 46 in Mahoning County as the "Officer T.J. D'Apolito Memorial Highway."
