**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 334** - Representatives Grim, Miranda.

To amend section 4141.29 and to enact sections 4141.294 and 4141.295 of the Revised Code to enact the Strike Term Access to Negotiation Duration Unemployment Protection Act (STAND UP Act) regarding unemployment benefits during labor disputes.

**H. B. No. 335** - Representative Swearingen.

To enact section 5534.663 of the Revised Code to designate a portion of State Route 163 in Ottawa County as the "Ottawa County Veterans Memorial Highway."

To enact sections 3902.63 and 5164.18 of the Revised Code to prohibit a health benefit plan and the Medicaid program from denying a claim for dental services on the basis of the age of the patient.

To amend sections 5123.01 and 5126.01 of the Revised Code to recognize Prader-Willi syndrome as a developmental disability.

**H. B. No. 338** - Representatives White, Sweeney.

Cosponsors: Representatives Plummer, Hillyer, Baker, Liston, Brennan, Miller, A.

To amend sections 3119.01, 3119.66, 3119.86, and 3119.88 and to enact sections 3109.20, 3119.10, 3119.11, 3119.12, 3119.861, 3119.862, and 3119.863 of the Revised Code to allow child support orders to be issued, modified, or extended for children over 18 with a disability.
