Tuesday, January 31, 2023, 9:00 o'clock a.m.

The hour having arrived for the meeting of the two houses in joint convention for the purpose of listening to the address of the Honorable Mike DeWine, Governor of the State of Ohio, before the joint convention.

The members of the Senate preceded by the President and Clerk appeared within the bar of the House.

The President of the Senate called the joint convention to order.

Senator Schuring and Representative Oelslager announced that a quorum of each house, respectively, was present.

Prayer was offered by Associate Pastor Ann Palmerton, from the Broad Street Presbyterian Church, Columbus, Ohio. Officers from the Ohio Department of Natural Resources presented the colors, followed by the Pledge of Allegiance to the Flag and the posting of the colors.

The Governor was escorted to the rostrum by the committee appointed where he addressed the joint convention.

On motion of Senator Schuring, the joint convention was dissolved.

The House met pursuant to adjournment.

The journal of the previous legislative day was read and approved.
