The House met pursuant to adjournment.

The journal of the previous legislative day was read and approved.

**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 616** - Representative Claggett.

To enact sections 6120.01, 6120.02, 6120.03, 6120.031, 6120.032, 6120.04, 6120.05, 6120.06, 6120.07, 6120.08, 6120.09, 6120.10, 6120.11, 6120.12, 6120.13, 6120.14, 6120.15, 6120.16, 6120.17, 6120.18, and 6120.19 of the Revised Code to allow for the creation of water improvement districts and to declare an emergency.

**H. B. No. 617** - Representative Wiggam.

Cosponsors: Representatives Click, Dean, Gross, Hall, Johnson, King, Merrin, Miller, K., Richardson, Stewart, Swearingen, Willis.

To enact section 9.59 of the Revised Code to protect individuals from being compelled to wear a mask or other facial covering.

**H. B. No. 618** - Representative Schmidt.

To amend section 4112.01 and to enact sections 124.92, 2701.21, and 4112.20 of the Revised Code to define antisemitism for the purpose of investigations and proceedings in courts and state agencies and for state employee anti-bias training.

**H. B. No. 619** - Representatives Schmidt, Denson.

To amend sections 1751.62, 3923.52, 3923.53, 5162.20, and 5164.08 of the Revised Code to revise the law governing insurance and Medicaid coverage of breast cancer screenings and examinations.

**H. B. No. 620** - Representative Klopfenstein.

To enact section 5534.848 of the Revised Code to designate U.S. 24 in Paulding County as the "Paulding County Purple Heart Memorial Highway."

**H. B. No. 621** - Representative Klopfenstein.

To enact section 5534.849 of the Revised Code to designate U.S. 30 in Van Wert County as the "Van Wert County Veteran's Memorial Highway."

**H. B. No. 622** - Representative Cutrona.

To amend section 5747.48 and to enact section 3375.68 of the Revised

Code to require each board of public library trustees to adopt a policy that prohibits its libraries from displaying matter harmful to juveniles and to redistribute the public library funds of libraries that fail to do so.

**H. B. No. 623** - Representatives Dobos, Jones.

Cosponsors: Representatives Williams, Upchurch, Dean, Hall, Brennan, McClain, Robb Blasdel.

To amend sections 3313.603, 3314.03, 3326.15, and 3328.22 and to enact section 3313.6030 of the Revised Code and to amend Section 733.61 of H.B. 166 of the 133rd General Assembly, as subsequently amended, to codify it as section 3313.6031 of the Revised Code to require school districts to offer at least one high school computer science course and to amend the version of section 3314.03 of the Revised Code that is scheduled to take effect on January 1, 2025, to continue the changes on and after that effective date.

**H. B. No. 624** - Representative Lipps.

To amend sections 9.45, 2925.01, 4710.01, 4710.02, 4710.03, 4710.04, 4712.01, and 4712.99; to amend, for the purpose of adopting new section numbers as indicated in parentheses, sections 4710.01 (4712.50), 4710.02 (4712.51), 4710.03 (4712.52), and 4710.04 (4712.53); to enact sections 4712.502, 4712.54, and 4712.55; and to repeal section 4710.99 of the Revised Code regarding debt adjusting.

**H. B. No. 625** - Representative Cutrona.

To amend sections 4501.21 and 4503.583 and to enact section 4503.896 of the Revised Code to create the "American Legion Auxiliary" license plate and to revise the requirements for the issuance of the "American Legion" license plate.

Said bills were considered the first time.
