# **INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 471 -** Representatives Creech, King. Cosponsors: Representatives Cutrona, Barhorst, Bird, Click, Gross, Hall, Johnson, Kick, Klopfenstein, Lear, Miller, M., Miller, K., Seitz, Wiggam, Williams.

To amend sections 3513.041 and 3513.05 and to enact section 3513.053 of the Revised Code to allow an elector who is not a member of a political party to protest a person's candidacy for that party's nomination on certain grounds.

To amend sections 111.26, 111.44, 3501.01, 3501.05, 3501.11, 3501.17, 3501.22, 3501.30, 3503.01, 3503.07, 3503.09, 3503.10, 3503.11, 3503.13, 3503.14, 3503.15, 3503.151, 3503.153, 3503.16, 3503.19, 3503.20, 3503.21, 3503.24, 3503.26, 3503.28, 3503.29, 3503.33, 3505.18, 3505.181, 3505.182, 3505.183, 3505.19, 3505.20, 3506.01, 3506.03, 3506.04, 3506.05, 3506.06, 3506.07, 3506.08, 3506.09, 3506.10, 3506.15, 3506.23, 3509.02, 3509.03, 3509.04, 3509.05, 3509.06, 3509.07, 3509.08, 3509.09, 3511.02, 3511.04, 3511.05, 3511.09, 3511.11, 3513.18, 3513.19, 3599.12, and 4507.53; to amend, for the purpose of adopting a new section number as indicated in parentheses, section 3503.153 (3503.155); to enact new sections 3503.152 and 3503.153 and sections 3503.154, 3503.201, 3503.231, 3506.022, 3506.051, 3506.052, 3506.053, 3506.054, 3506.101, and 3506.141; and to repeal sections 3503.111, 3503.152, 3503.18, 3505.22, 3506.021, 3506.24, 3511.12, 3511.13, and 3513.20 of the Revised Code to make changes to the Election Law related to voter registration, voting, and the certification of voting systems.

H. B. No. 473 - Representative McNally.

To amend section 5501.03 of the Revised Code to require ODOT to install and maintain security camera systems at rest stops and to require the director of transportation to consult with the director of public safety and the attorney general regarding such installation.

# H. B. No. 474 - Representatives King, Mathews.

To amend sections 1716.01 and 5747.01 and to enact sections 1716.22 and 3333.96 of the Revised Code to enact the Health Care Sharing Ministries Freedom to Share Act.

# H. B. No. 475 - Representative Williams.

Cosponsors: Representatives Click, Dean, Claggett, Wiggam, King, Schmidt, Swearingen, Gross, Richardson, Klopfenstein, McClain.

To amend sections 5747.50, 5747.502, 5747.51, and 5747.53 and to enact sections 9.042, 305.44, 701.11, 3701.651, 5747.504, and 5747.505 of the Revised Code to prohibit state funds from being given to any entity that supports, promotes, or provides abortions, to require counties and municipal corporations to report abortion-related spending, and to withhold and reallocate to pregnancy resource centers state local government funds from a county or municipal corporation that engages in such spending.

# H. B. No. 476 - Representatives Cutrona, Hillyer.

To enact sections 1357.01, 1357.02, 1357.04, 1357.05, 1357.06, 1357.07, 1357.08, 1357.09, 1357.10, 1357.11, 1357.12, and 1357.13 of the Revised Code to create a regulatory relief office within the Department of Commerce and establish a universal regulatory sandbox program under which the office may temporarily waive certain state laws and regulations and allow businesses to demonstrate innovative products and services.

# H. B. No. 477 - Representative Willis.

Cosponsors: Representatives Dean, Brown, Barhorst, Gross.

To amend sections 4561.01 and 4561.11 of the Revised Code to incorporate seaplane bases, heliports, vertiports, and spaceports into the Aeronautics Law.

# H. B. No. 478 - Representatives Edwards, LaRe.

To amend section 2909.07 and to enact sections 1923.16 and 2913.53 of the Revised Code to provide for the expedited removal of unauthorized occupants of residential property and to prohibit the use and sale of fraudulent deeds.

**H. B. No. 479 -** Representatives Holmes, Thomas, C. Cosponsors: Representatives Brennan, Denson, Klopfenstein, McNally, Powell, Weinstein.

To enact section 5.2471 of the Revised Code to designate September 19 as "Ohio Stillbirth Prevention Day."

To amend section 2909.07 and to enact sections 1923.16 and 2913.53 of the Revised Code to provide for the expedited removal of unauthorized occupants of residential property, to prohibit the use and sale of fraudulent deeds, and to declare an emergency.

To amend sections 135.01, 135.31, and 5747.01 and to enact section 113.07 of the Revised Code to require the Treasurer of State to accept bullion or specie as payment for any debt and to exempt the capital gain on the sale or exchange of bullion or specie from state and school district income taxes.
