# **INTRODUCTION OF BILLS**

The following bills were introduced:

### H. B. No. 404 - Representative Forhan.

To enact section 101.16 of the Revised Code regarding the use of personal electronic devices by General Assembly members.

# H. B. No. 405 - Representative Dell'Aquila.

Cosponsors: Representatives Brennan, Troy, McNally, Upchurch, Brown, Rogers, Lipps, Somani.

To amend sections 5747.08 and 5747.98 and to enact section 5747.86 of the Revised Code to authorize a refundable income tax credit for disability-related home expenses.

### H. B. No. 406 - Representative Demetriou.

Cosponsors: Representatives McClain, Williams.

To amend sections 301.30, 504.04, 715.013, 718.01, 1315.01, and 5747.01 and to enact sections 101.88, 1352.01, 1352.02, 1352.03, and 1352.04 of the Revised Code to prohibit certain state and local government actions respecting digital asset mining, to exempt certain digital currency transactions from state and local income taxes, to prohibit local charges on digital assets, to require the state retirement systems to evaluate certain digital asset investments, and to name this act the Ohio Blockchain Basics Act.

# H. B. No. 407 - Representatives Manning, Seitz.

To amend sections 3301.0711, 3310.03, 3310.13, 3310.14, 3310.15, 3313.618, 3313.619, 3313.976, 3314.03, 3319.324, 3326.11, and 3328.24 and to enact sections 3301.165, 3301.166, 3301.167, 3302.0311, and 3313.6612 of the Revised Code regarding chartered nonpublic schools that participate in certain scholarship programs and disciplinary record requirements for schools and to amend the version of section 3314.03 of the Revised Code that is scheduled to take effect on January 1, 2025, to continue the change on and after that date.

**H. B. No. 408 -** Representatives Brewer, Mohamed. Cosponsors: Representatives Russo, Brent, Jarrells, Rogers, Weinstein, Miranda, McNally, Denson, Troy, Williams. To amend sections 3314.03, 3326.11, and 3328.24 and to enact section 3313.819 of the Revised Code to require public schools to provide meals and related services to students.

# H. B. No. 409 - Representative Miller, J.

Cosponsors: Representatives McNally, Brennan, Thomas, C., Forhan, Weinstein, Russo, Grim, Miranda, Somani, Miller, A., Jarrells, Dell'Aquila, Rogers.

To amend section 5902.02 and to enact sections 5902.09 and 5919.21 of the Revised Code to create the Ohio Cold War Victory Medal.

# H. B. No. 410 - Representative Miller, J.

Cosponsors: Representatives Forhan, Brennan, Dell'Aquila, Seitz, Russo, Weinstein, Grim, Miranda, Somani, Miller, A., Jarrells, Miller, K., McNally, Rogers, Thomas, C.

To amend section 3599.40 and to enact section 3517.24 of the Revised Code to regulate the dissemination of deepfake media for the purpose of influencing the results of an election.

H. B. No. 411 - Representative Miller, J.

To amend section 3317.13 of the Revised Code to increase the base teacher salary to \$50,000.
